**APPLICANT’S STATEMENT OF THE CASE**

In **Case No. 23895**, Matador seeks an order to amend Order No. R-22395 (“Pooling Order”) to allow for an extension of time for drilling the proposed initial well under the Pooling Order. On November 22, 2022, the Division entered Order No. R-22395 in Case No. 22571 pooling the uncommitted interests in the Bone Spring formation (WC-025 G-08 S2535340; Bone Spring [97088]) underlying a standard 320-acre, more or less, horizontal spacing unit comprised of the W/2 SE/4 of Section 18, the W/2 E/2 of Section 19, and the W/2 NE/4 of Section 30, Township 24 South, Range 36 East, NMPM, Lea County, New Mexico. Matador is the designated operator under the Pooling Order and the pooled spacing unit is initially dedicated to the proposed **Huneke Fed Com 137H** well (API No. 30-025-PENDING).

In **Case No. 23896**, Matador seeks an order to amend Order No. R-22396 (“Pooling Order”) to allow for an extension of time for drilling the proposed initial well under the Pooling Order. On November 22, 2022, the Division entered Order No. R-22398 in Case No. 22574 pooling the uncommitted interests in the Wolfcamp formation (Jal; Wolfcamp, West [33813]) underlying a standard 320-acre, more or less, horizontal spacing unit comprised of the E/2 SE/4 of Section 18, the E/2 E/2 of Section 19, and the E/2 NE/4 of Section 30, Township 24 South, Range 36 East, NMPM, Lea County, New Mexico. Matador is the designated operator under the Pooling Order and the pooled spacing unit is initially dedicated to the proposed **Huneke Fed Com 214H** well (API No. 30-025-PENDING).

There is good cause for Applicant’s request for an extension of time to drill. Matador filed previously applied for drilling permits with the Bureau of Land Management (“BLM”) and has not yet received approval.
