STATEMENT OF THE CASE

Applicant in the above-styled cause seeks an order from the Oil Conservation Division pooling all uncommitted mineral interests in the Wolfcamp formation (GATUNA CANYON;

WOLFCAMP [27191]) in a standard 640-acre, more or less, horizontal spacing and proration unit ("HSU"), including proximity tracts, comprised of the N/2 of Sections 35 and 36, all in Township 19 South, Range 29 East, in Eddy County, New Mexico. Applicant proposes to drill the following 2-mile wells in the HSU:

- Ironhorse 35-36 Fed State #200H well, to be horizontally drilled from an approximate surface hole location in Lot H of Section 34, T19S-R29E, to an approximate bottom hole location 10' FEL and 993' FNL of Section 36, T19S-R29E.
- Ironhorse 35-36 Fed State #201H well, to be horizontally drilled from an approximate surface hole location in Lot H of Section 34, T19S-R29E, to an approximate bottom hole location 10' FEL and 2,310' FNL of Section 36, T19S-R29E.

The (GATUNA CANYON; WOLFCAMP [27191]) pool is an oil pool. The **Ironhorse 35-36 Fed State #200H** is a proximity well. With proximity tracts, the completed intervals and first and last take points for both wells will meet the setback requirements set forth in the statewide rules for horizontal oil wells.

Additional considerations will be the cost of drilling and completing the wells and allocation of such costs, the designation of Applicant as operator of the HSU and wells to be drilled thereon, and a 200% charge for the risk involved in drilling and completing the wells. The wells and lands are located approximately 12 miles North of Carlsbad, New Mexico.
