In Case No. 23905, Franklin seeks an order from the Division pooling all uncommitted mineral interests within a 319.68-acre, more or less, Bone Spring horizontal spacing unit comprising the E/2 E/2 of Section 33, Township 18 South, Range 35 East, and Lot 1, the SE/4 NE/4 and E/2 SE/4 of Section 4 (E/2 E/2 equivalent), Township 19 South, Range 35 East, N.M.P.M., Lea County, New Mexico. This spacing unit will be dedicated to the **Alpha State Com 304H well**, to be horizontally drilled. The producing area for the well is expected to be orthodox. Also to be
