## STATEMENT OF CASE

### **APPLICANT:**

In Case No. 23906, Franklin seeks an order from the Division pooling all uncommitted mineral interests within a 400-acre, more or less, Bone Spring horizontal spacing unit comprising the E/2 SW/4 of Section 24 and the E/2 W/2 of Sections 25 and 36, Township 19 South, Range 35 East, N.M.P.M., Lea County, New Mexico. This spacing unit will be dedicated to the **Sun State Com 502H well**, to be horizontally drilled. The producing area for the well is expected to be orthodox. Also to be considered will be the cost of drilling and completing said well, the allocation of these

costs as well as the actual operating costs and charges for supervision, designation of Franklin Mountain Energy 3, LLC as operator of the well, and a 200% charge for risk involved in drilling said well. Said area is located approximately 18 miles southwest of Hobbs, New Mexico.
