STATEMENT OF THE CASE

Permian Resources applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying a 640-acre, more or less, standard horizontal spacing unit comprised of the S/2 of Sections 35 and 36, Township 19 South, Range 29 East, Eddy County, New Mexico ("Unit"). The Unit will be dedicated to the following wells ("Wells"):

- a. Silver Bar 35-36 Fed State Com 202H well, which will be drilled from a surface hole location in the SE/4 SE/4 (Unit P) of Section 34 to a bottom hole location in the NE/4 SE/4 (Unit I) of Section 36; and
- b. Silver Bar 35-36 Fed State Com 203H well, which will be drilled from a surface hole location in the SE/4 SE/4 (Unit P) of Section 34 to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 36.

The completed intervals of the Wells will be orthodox. The completed interval of the **Silver Bar 35-36 Fed State Com 202H** well will be located within 330' of the quarter-quarter section line separating the N/2 S/2 and S/2 S/2 of Sections 35 and 36 to allow for the creation of a standard 640-acre horizontal spacing unit.

Also to be considered will be the cost of drilling and completing the Wells and the allocation of the costs, the designation of Applicant as the operator of the Wells, and a 200% charge for the risk involved in drilling and completing the Wells.

The Wells are located approximately 13 miles northwest of Carlsbad, New Mexico.
