APPLICANT’S STATEMENT OF CASE

In these consolidated cases, Mewbourne seeks orders pooling all uncommitted interests in the Bone Spring formation [Antelope Ridge; Bone Spring Pool (2200)] underlying the E2 of Sections 26 and 35, Township 23 South, Range 41 East, NMPM, Lea County, New Mexico as follows:

- Under **Case 24071**, Mewbourne seeks to pool a 320-acre standard horizontal well spacing unit comprised of E2E2 of Sections 26 and 35 to be initially dedicated to the proposed **Mad Dog 26/35 State Com 318H, Mad Dog 26/35 State Com 408H, Mad Dog 26/35 State Com 528H, and Mad Dog 26/35 State Com 588H** wells to be horizontally drilled from a surface location in the NW4NE4 (Unit B) of Section 26 to bottom hole locations in the SE4SE4 (Unit P) of Section 35.
- Under **Case 24072**, Mewbourne seeks to pool a 320-acre standard horizontal well spacing unit comprised of W2E2 of Sections 26 and 35 to be initially dedicated to the proposed **Mad Dog 26/35 State Com 405H, Mad Dog 26/35 State Com 526H, and Mad Dog 26/35 State Com 585H** wells to be horizontally drilled from a surface location in the NW4NE4 (Unit B) of Section 26 to bottom hole locations in the SW4SE4 (Unit O) of Section 35.

Mewbourne has sought but been unable to obtain voluntary agreement for the development of these lands from all mineral interest owners in the subject acreage.
