COG seeks orders pooling four standard horizontal well spacing units in the Wolfcamp formation underlying Sections 20 & 29, Township 24 South, Range 32 East, NMPM, Lea County, New Mexico as follows:

- Under <u>Case 24097</u> COG seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre horizontal well spacing unit comprised of the E2E2 of Sections 20 & 29 to be initially dedicated to the proposed Azores Federal Com 701H and Azores Federal Com 702H wells to be horizontally drilled from a surface location in the SE4 of Section 29, with first take points in the SE4SE4 (Unit P) of Section 29 and last take points in the NE4NE4 (Unit A) of Section 20.
- Under <u>Case 24098</u> COG seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre horizontal well spacing unit comprised of the W2E2 of Sections 20 & 29 to be initially dedicated to the proposed Azores Federal Com 703H and Azores Federal Com 707H wells to be horizontally drilled from a surface location in the SE4 of Section 29, with first take points in the SW4SE4 (Unit O) of Section 29 and last take points in the NW4NE4 (Unit B) of Section 20.

Under <u>Case 24100</u> COG seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre horizontal well spacing unit comprised of the W2W2 of Sections 20 & 29 to be initially dedicated to the proposed Azores Federal Com 706H and Azores Federal Com 708H wells to be horizontally drilled from a surface location in the SW4 of Section 29, with first take points in the SW4SW4 (Unit M) of Section 29 and last take points in the NW4NW4 (Unit D) of Section 20.
