APPLICANT'S STATEMENT OF THE CASE

Under these consolidated cases, MRC seeks orders pooling all uncommitted interests in the Bone Spring formation (Sand Tank; Bone Spring [96832]) underlying the referenced acreage as follows:

- Under **Case No. 24133**, MRC seeks to pool the uncommitted interests in a standard 310.82-acre, more or less, horizontal well spacing unit comprised of the N/2 NE/4, NE/4 NW/4 and Lot 1 of irregular Section 18 (N/2 N/2 equivalent), Township 18 South, Range

29 East, and the N/2 N/2 of Section 13, Township 18 South, Range 28 East, NMPM, Eddy County, New Mexico and initially dedicate this Bone Spring spacing unit to the proposed **Stephanie 0712 Fed Com 131H** well, to be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of irregular Section 7, T18S-R29E, with a first take point in the NE/4 NE/4 (Unit A) of irregular Section 18, T18S-R29E, and a last take point in the NW/4 NW/4 (Unit D) of Section 13, T18S-R28E.

- Under **Case No. 24134**, MRC seeks to pool the uncommitted interests in a standard 310.68-acre, more or less, horizontal well spacing unit comprised of the S/2 SE/4, SE/4 SW/4 and Lot 4 of irregular Section 7 (S/2 S/2 equivalent), Township 18 South, Range 29 East, and the S/2 S/2 of Section 12, Township 18 South, Range 28 East, NMPM, Eddy County, New Mexico and initially dedicate this Bone Spring spacing unit to the proposed **Stephanie 0712 Fed Com 134H** well, to be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of irregular Section 7, T18S-R29E, with a first take point in the same and a last take point in the SW/4 SW/4 (Unit M) of Section 12, T18S-R28E.

The completed interval for each of the wells will comply with statewide setbacks for oil wells. MRC has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject acreage.
