APPLICANT’S STATEMENT OF THE CASE

Under these consolidated cases, Devon seeks orders pooling all uncommitted interests in the Wolfcamp formation (Jabalina; Wolfcamp [96776]) underlying the referenced acreage all in Township 26, Range 34 East, NMPM, Lea County, New Mexico, as follows:

- Under **Case No. 24136**, Devon seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 235.99-acre standard horizontal spacing unit comprised of the W/2 W/2 of Section 27 and the NW/4 NW/4 and Lot 4 of irregular Section 34 (W/2

NW/4 equivalent) and initially dedicate this Wolfcamp spacing unit to the **Boll Weevil 27-34 Fed Com 2H**, to be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 27, with a first take point in the same and a last take point in the SW/4 NW/4 equivalent (Lot 4) of Section 34. Lot 4 of irregular Section 34 borders the Texas state line.

- Under **Case No. 24137**, Devon seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 235.93-acre standard horizontal spacing unit comprised of the E/2 W/2 of Section 27 and the NE/4 NW/4 and Lot 3 of irregular Section 34 (E/2 NW/4 equivalent) and initially dedicate this Wolfcamp spacing unit to the **Boll Weevil 27-34 Fed Com 3H**, to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 27, with a first take point in the same and a last take point in Lot 3 (SE/4 NW/4 equivalent) of irregular Section 34. Lot 3 of irregular Section 34 borders the Texas state line.
- Under **Case No. 24139**, Devon seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 235.87-acre standard horizontal spacing unit comprised of the W/2 E/2 of Section 27 and the NW/4 NE/4 and Lot 2 of irregular Section 34 (W/2 NE/4 equivalent) and initially dedicate this Wolfcamp spacing unit to the **Boll Weevil 27-34 Fed Com 5H**, **Boll Weevil 27-34 Fed Com 6H**, and **Boll Weevil 27-34 Fed Com 10H**, each to be horizontally drilled from a surface location in the NW/4 NE/4 (Unit B) of Section 27, with a first take point in the same and a last take point in Lot 2 (SW/4 NE/4 equivalent) of irregular Section 34. Lot 2 of irregular Section 34 borders the Texas state line.

The completed interval for the **Boll Weevil 27-34 Fed Com 2H** and **Boll Weevil 27-34 Fed Com 6H** wells, both comply with statewide setbacks for oil wells. The **Boll Weevil 27-34 Fed Com 3H**, **Boll Weevil 27-34 Fed Com 5H**, and **Boll Weevil 27-34 Fed Com 10H** will be at a non-standard location; therefore, because the laterals are located wholly within an area of uniform ownership as to the mineral estate, Devon has filed a C-103 for each well, along with the examiner required materials, attesting to said uniform ownership. *See* 19.15.16.15.C.7 NMAC.

Devon has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject acreage.
