## APPLICATION OF BTA OIL PRODUCERS, LLC FOR COMPULSORY POOLING, LEA COUNTY, NEW MEXICO

## **APPLICATION**

In accordance with NMSA 1978, § 70-2-17, BTA Oil Producers, LLC ("BTA" or "Applicant"), through its undersigned attorneys, files this application with the Oil Conservation Division ("Division") seeking an order pooling all uncommitted interests from the top of the First Bone Spring formation to the base of the Second Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 E/2 of Sections 11 and 14, Township 22 South, Range 34 East, Lea County, New Mexico ("Unit"). In support of this application, BTA states the following.

1. Applicant (OGRID No. 260297) is a working interest owner in the Unit and has the right to drill wells thereon.

2. Applicant seeks to dedicate the Unit to the **Crazy Goat 8711 14-11 State Com** #4H and **Crazy Goat 8711 14-11 State Com** #6H wells ("Wells"), which will be drilled from surface hole locations in the SW/4 SE/4 (Unit O) of Section 14 to bottom hole locations in the NE/4 NE/4 (Unit A) of Section 11.

3. The completed intervals of the Wells will be orthodox.

4. There is a depth severance in the Bone Spring formation within the Unit. Accordingly, BTA seeks to pool interests from the top of the First Bone Spring to the base of the Second Bone Spring at a stratigraphic equivalent of 10,444' as shown in the Schlumberger Compensated Neutron/Litho Density Log, Run No. 1 (January 2, 1988) for the 8711 Chiso #1 Wellbore (API #30-025-30141).

5. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the Unit.

6. The pooling of uncommitted interests will avoid the drilling of unnecessary wells, prevent waste, and protect correlative rights.

7. In order to permit Applicant to obtain its just and fair share of the oil and gas underlying the subject lands, all uncommitted interests in the Unit should be pooled and Applicant should be designated the operator of the proposed horizontal wells and the Unit.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on March 7, 2024, and, after notice and hearing as required by law, the Division enter an order:

- A. Pooling all uncommitted interests in the Unit;
- B. Approving the initial wells in the Unit;
- C. Designating Applicant as the operator of the Unit and the horizontal wells to be drilled thereon;
- D. Authorizing Applicant to recover its costs of drilling, equipping, and completing the wells;
- E. Approving the actual operating charges and costs of supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and
- F. Imposing a 200% charge for the risk assumed by Applicant in drilling and completing the wells against any working interest owner who does not voluntarily participate in the drilling of the wells.
