APPLICANT’S STATEMENT OF THE CASE

Under **Case No. 24133**, MRC seeks to pool the uncommitted interests in the Bone Spring formation (Sand Tank; Bone Spring [96832]) underlying a standard 310.82-acre, more or less, horizontal well spacing unit comprised of the N/2 NE/4, NE/4 NW/4 and Lot 1 of irregular Section 18 (N/2 N/2 equivalent), Township 18 South, Range 29 East, and the N/2 N/2 of Section 13, Township 18 South, Range 28 East, NMPM, Eddy County, New Mexico. MRC seeks to initially dedicate this spacing unit to the proposed **Stephanie 0712 Fed Com 131H** well, to be horizontally

drilled from a surface location in the SE/4 SE/4 (Unit P) of irregular Section 7, T18S-R29E, with a first take point in the NE/4 NE/4 (Unit A) of irregular Section 18, T18S-R29E, and a last take point in the NW/4 NW/4 (Unit D) of Section 13, T18S-R28E.

The completed interval for the well will comply with statewide setbacks for oil wells. MRC has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject acreage.
