STATEMENT OF THE CASES

In Case No. 24164, Colgate seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of Section 7, Township 19 South, Range 28 East, and the N/2 NE/4 of Section 12, Township 19 South, Range 27 East, Eddy County, New Mexico. The unit will be dedicated to the

Alpine 7-12 State 121H and **Alpine 7-12 State 131H** wells, which will be drilled from surface hole locations in the SE/4 NE/4 (Unit H) of Section 7, Township 19 South, Range 28 East, to bottom hole locations in the NW/4 NE/4 (Unit B) of Section 12, Township 19 South, Range 27 East.

In Case No. 24165, Colgate seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the S/2 N/2 of Section 7, Township 19 South, Range 28 East, and the S/2 NE/4 of Section 12, Township 19 South, Range 27 East, Eddy County, New Mexico. The unit will be dedicated to the **Alpine 7-12 State 122H** and **Alpine 7-12 State 132H** wells, which will be drilled from surface hole locations in the SE/4 NE/4 (Unit H) of Section 7, Township 19 South, Range 28 East, to bottom hole locations in the SW/4 NE/4 (Unit G) of Section 12, Township 19 South, Range 27 East.

In Case No. 24166, Colgate seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the N/2 S/2 of Section 7, Township 19 South, Range 28 East, and the N/2 SE/4 of Section 12, Township 19 South, Range 27 East, Eddy County, New Mexico. The unit will be dedicated to the **Alpine 7-12 State 123H** and **Alpine 7-12 State 133H** wells, which will be drilled from surface hole locations in the NE/4 SE/4 (Unit I) of Section 7, Township 19 South, Range 28 East, to bottom hole locations in the NW/4 SE/4 (Unit J) of Section 12, Township 19 South, Range 27 East.

In Case No. 24167, Colgate seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the S/2 S/2 of Section 7, Township 19 South, Range 28 East, and the S/2 SE/4 of Section 12, Township 19 South, Range 27 East, Eddy County, New Mexico. The unit will be dedicated to the

Alpine 7-12 State 124H and **Alpine 7-12 State 134H** wells, which will be drilled from surface hole locations in the NE/4 SE/4 (Unit I) of Section 7, Township 19 South, Range 28 East, to bottom hole locations in the SW/4 SE/4 (Unit O) of Section 12, Township 19 South, Range 27 East.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Permian Resources Operating, LLC as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The wells are located approximately 18 miles northeast of Carlsbad, New Mexico.
