MRC Permian Company ("MRC" or "Applicant"), through undersigned attorneys, hereby files this application with the Oil Conservation Division pursuant to the provisions of NMSA 1978, § 70-2-17, for an order pooling a standard 323.92-acre, more or less, horizontal well spacing unit in the Wolfcamp formation comprised of the W2E2 oof Section 35, Township 18 South, Range 34 East; and Lot 2, SW4NE4 and W2SE4 (W2E2 equivalent) of irregular Section 2, Township 19 South, Range 34 East and, NMPM, Lea County, New Mexico. In support of its application, MRC states:

1. Applicant is a working interest owner in the proposed horizontal spacing unit and has the right to drill thereon.

2. Applicant seeks to designate Matador Production Company (OGRID No. 228937) as the operator of the proposed horizontal well spacing unit.

3. Applicant seeks to initially dedicate the above-referenced horizontal spacing unit to the proposed **Mark McKinley State Com 243H** well to be horizontally drilled from a surface location in the SE4 of Section 26, with a first take point in the NW4NE4 (Unit B) of Section 35 and a last take point in the SW4SE4 (Unit O) of Section 2.

4. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject spacing unit.

5. The pooling of this horizontal well spacing unit will allow Applicant to obtain a just and fair share of the oil and gas underlying the subject lands, avoid the drilling of unnecessary wells, will prevent waste, and will protect correlative rights.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on April 4, 2024, after notice and hearing as required by law, the Division enter an order:

- A. Pooling all uncommitted interest owners in the proposed horizontal well spacing unit;
- B. Designating Matador Production Company as operator of this horizontal spacing unit and the horizontal wells to be drilled thereon;
- C. Authorizing Applicant to recover its costs of drilling, completing, and equipping the well;
- D. Approving the actual operating charges and costs of supervision while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and
- E. Imposing a 200% charge for the risk assumed by Applicant in drilling and completing the well against any working interest owner who does not voluntarily participate in the drilling of the well.

Application of MRC Permian Company for Compulsory Pooling, Lea County, New Mexico. Applicant in the above-styled cause seeks an order pooling a standard 323.92-acre, more or less, horizontal well spacing unit in the Wolfcamp formation comprised of the W2E2 oof Section 35, Township 18 South, Range 34 East; and Lot 2, SW4NE4 and W2SE4 (W2E2 equivalent) of irregular Section 2, Township 19 South, Range 34 East and, NMPM, Lea County, New Mexico. Said unit will be initially dedicated to the proposed Mark McKinley State Com 243H well to be horizontally drilled from a surface location in the SE4 of Section 26, with a first take point in the NW4NE4 (Unit B) of Section 35 and a last take point in the SW4SE4 (Unit O) of Section 2.
