STATEMENT OF CASE

APPLICANT:

In Case No. 24188, Marathon seeks an order from the Division pooling all uncommitted mineral interests within a standard 960-acre, more or less, Bone Spring horizontal spacing unit underlying the W/2 of Section 35, Township 22 South, Range 28 East, and the W/2 of Sections 2 and 11, Township 23 South, Range 28 East, NMPM, Eddy County, New Mexico. This spacing unit will be dedicated to the **Trojan Shield Federal Com 301H** and **Trojan Shield Federal Com 501H** wells to be horizontally drilled with first take points in the NW/4 NW/4 (Unit D) of Section 35 and with last take points in the SW/4 SW/4 (Unit M) of Section 11; and the **Trojan Shield Federal Com 302H** and **Trojan Shield Federal Com 502H** wells to be horizontally drilled with

first take points in the NE/4 NW/4 (Unit C) of Section 35 and will last take points in the SE/4 SW/4 (Unit N) of Section 11. The producing area for the wells is expected to be orthodox. The completed interval for the Trojan Shield Federal Com 301H is expected to be less than 330 feet from the adjoining tracts thereby allowing for the inclusion of the proximity tracts within the proposed spacing unit. Applicant also seeks, to the extent necessary, approval of an overlapping spacing unit. The proposed spacing unit will partially overlap the following Bone Spring spacing unit:

- A 40-acre horizontal well spacing unit comprised of the SW/4 SW/4 of Section 11, Township 23 South, Range 28 East, dedicated to BTA Oil Producers, LLC's Pardue C 8808 JV-P #005 well (API 30-015-38999).

Also to be considered will be the cost of drilling and completing said wells, the allocation of these costs as well as the actual operating costs and charges for supervision, designation of Marathon as operator of the wells, and a 200% charge for risk involved in drilling said wells. Said area is located approximately 5.2 miles northeast of Loving, New Mexico.
