STATEMENT OF THE CASES

In Case Nos. 24208, 24209, 24210, and 24212, E.G.L. requests an extension of time to commence drilling operations under Order Nos. R-22552, R-22553, R-22554, and R-22555, respectively, due to delays in the issuance of federal drilling permits.

In Case No. 24208, E.G.L. seeks a one-year extension of time to commence drilling operations under Order No. R-22552, which was entered by the Division on March 30, 2023. Order

No. R-22552 pooled all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 W/2 of Sections 22 and 27, Township 19 South, Range 33 East, Lea County, New Mexico, and dedicated the unit to the Moonraker 22-27 Fed. Com. Well No. 201H.

In Case No. 24209, E.G.L. seeks a one-year extension of time to commence drilling operations under Order No. R-22553, which was entered by the Division on March 30, 2023. Order No. R-22553 pooled all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Sections 22 and 27, Township 19 South, Range 33 East, Lea County, New Mexico, and dedicated the unit to the Moonraker 22-27 Fed. Com. Well No. 202H.

In Case No. 24210, E.G.L. seeks a one-year extension of time to commence drilling operations under Order No. R-2554, which was entered by the Division on March 30, 2023. Order No. R-22554 pooled all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 W/2 of Sections 22 and 27, Township 19 South, Range 33 East, Lea County, New Mexico, and dedicated the unit to the Moonraker 22-27 Fed. Com. Well No. 501H.

In Case No. 24212, E.G.L. seeks a one-year extension of time to commence drilling operations under Order No. R-22555, which was entered by the Division on March 30, 2023. Order No. R-22555 pooled all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Sections 22 and 27, Township 19 South, Range 33 East, Lea County, New Mexico, and dedicated the unit to the Moonraker 22-27 Fed. Com. Well No. 502H.

The wells are located approximately 8.5 miles northeast of Halfway, New Mexico.
