STATEMENT OF THE CASES

In Case No. 24129, BTA applies for an order pooling all uncommitted interests from the top of the First Bone Spring formation to the base of the Second Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 E/2 of Sections 11

and 14, Township 22 South, Range 34 East, Lea County, New Mexico. The Unit will be dedicated to the Crazy Goat 8711 14-11 State Com #3H and Crazy Goat 8711 14-11 State Com #5H wells, which will be drilled from surface hole locations in the SW/4 SE/4 (Unit O) of Section 14 to bottom hole locations in the NW/4 NE/4 (Unit B) of Section 11.

In Case No. 24220, BTA applies for an order pooling all uncommitted interests from the top of the First Bone Spring formation to the base of the Second Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 E/2 of Sections 11 and 14, Township 22 South, Range 34 East, Lea County, New Mexico. The Unit will be dedicated to the Crazy Goat 8711 14-11 State Com #4H and Crazy Goat 8711 14-11 State Com #6H wells, which will be drilled from surface hole locations in the SW/4 SE/4 (Unit O) of Section 14 to bottom hole locations in the NE/4 NE/4 (Unit A) of Section 11.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as the operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The wells are located approximately 27 miles southwest of Hobbs, New Mexico.
