APPLICANT'S STATEMENT OF THE CASE

In **Case 24265**, Crockett seeks to amend pooling Order No. R-22613 (“Pooling Order”) to add additional mineral owners to the pooling order and extend the drilling deadline under the Pooling Order. On March 30, 2023, the Division entered Order No. R-22613 in Case No. 23307, pooling the uncommitted interest owners in the San Andres formation (Bronco; San Andres South

[7500]) underlying a standard 480-acre, more or less, horizontal well spacing unit comprised of the E/2 of Section 31 and the SE/4 of Section 30, Township 13 South, Range 38 East, NMPM, Lea County, New Mexico. Crockett is the designated operator under the Pooling Order and the pooled spacing unit is initially dedicated to the **Ackbar 30 31 B Fee 5H** (API: 30-025-51013) well.

Applicant requests that Order No. R-22613 be re-opened and amended to add additional pooled parties and allow Applicant additional time to commence drilling the well under the Pooling Order. Applicant has discovered additional mineral owners in the pooled acreage that were not subject to the pooling proceedings giving rise to Order No. R-22613. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from these additional mineral owners. Additionally, there is good cause for Applicant’s request for an extension of time to drill.
