STATEMENT OF THE CASES

In Case No. 24270, Permian Resources applies for an order pooling all uncommitted interest in the Wolfcamp formation underlying a 640-acre, more or less, standard horizontal spacing unit comprised of the N/2 of Sections 10 and 11, Township 20 South, Range 26 East, Eddy County, New Mexico. The Unit will be dedicated to the following wells:

- **Mammoth 10 Com 201H** well, which will produce from a first take point in the NW/4 NW/4 (Unit D) of Section 10, to a last take point in the NE/4 NE/4 (Unit A) of Section 11; and
- **Mammoth 10 Com 202H** well, which will produce from a first take point in the SW/4 NW/4 (Unit E) or Section 10, to a last take point in the SE/4 NE/4 (Unit H) of Section 11.

In Case No. 24271, Permian Resources seeks an Order approving a 640-acre, more or less, standard horizontal spacing unit comprised of the S/2 of Sections 10 and 11, Township 20 South, Range 26 East, Eddy County, New Mexico. The Unit will be dedicated to the following wells:

- **Mammoth 10 Com 203H** well, which will produce from a first take point in the NW/4 SW/4 (Unit L) of Section 10, to a last take point in the NE/4 SE/4 (Unit I) of Section 11; and
- **Mammoth 10 Com 204H** well, which will produce from a first take point in the SW/4 SW/4 (Unit M) of Section 10, to a last take point in the SE/4 SE/4 (Unit P) of Section 11.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Permian Resources Operating, LLC as operator of the wells, and a 200% charge for the risk involved in

drilling and completing the wells. The surface location of the wells is approximately 1 mile west of Carlsbad, New Mexico.
