#### **STATEMENT OF THE CASES**

In these cases, Colgate seeks to pool additional interest owners under the terms of Order Nos. R-23010 and R-23011.

On January 10, 2024, the Division entered Order No. R-23010 in Case No. 23668, which pooled uncommitted interests in the Bone Spring formation underlying a standard horizontal

spacing unit comprised of the NW/2 NE/4 of Section 29 and the N/2 N/2 of Section 28, Township 18 South, Range 31 East, Eddy County, New Mexico. Order No. R-23010 further dedicated the Unit to the Silver 29-28 Fed Com 121H and Silver 29-28 Fed Com 131H wells and designated Permian Resources Operating, LLC (OGRID No. 372165) ("Permian Resources") as operator of the unit and wells.

On January 10, 2024, the Division entered Order No. R-23011 in Case No. 23669, which pooled uncommitted interests in the Bone Spring formation underlying a standard horizontal spacing unit comprised of the S/2 NE/4 of Section 29 and the S/2 N/2 of Section 28, Township 18 South, Range 31 East, Eddy County, New Mexico. Order No. R-23011 further dedicated the Unit to the Silver 29-28 Fed Com 122H and Silver 29-28 Fed Com 132H wells and designated Permian Resources as operator of the unit and wells.

Since Order Nos. R-23010 and R-23011 were entered, Colgate has identified additional uncommitted interests in the Unit that have not been pooled under the terms of the Order. Colgate requests that these additional interest owners be pooled under the terms of Order Nos. R-23010 and R-23011.
