SPC Resources, LLC (“Applicant”) (OGRID No. 372262) through its undersigned attorneys, hereby files this application with the Oil Conservation Division pursuant to the provisions of NMSA 1978, § 70-2-17, for an order pooling all uncommitted interests in the Bone Spring formation underlying a standard 635.06-acre, more or less, horizontal well spacing unit comprised of Lots 1-4 and the S/2 N/2 (N/2 equivalent) of irregular Section 5, and Lots 1-5, the SE/4 NW/4, and the S/2 NE/4 (N/2 equivalent) of irregular Section 6, Township 22 South, Range 27 East, NMPM, Eddy County, New Mexico. In support of its application, Applicant states:

1. Applicant is a working interest owner in the proposed horizontal spacing unit and has the right to drill thereon.
2. Applicant seeks to designate Permian Resources Operating, LLC (OGRID 372165) as the operator of the proposed horizontal well spacing unit.
3. Applicant seeks to initially dedicate the above-referenced horizontal spacing unit to the proposed following wells with a common surface location in the SE/4 NE/4 (Unit H) of said Section 5:
  - **Betty 131H well** with a first take point in the NE/4 NE/4 (Unit A) of said Section 5 and a last take point in NW/4 NW/4 (Unit D) of said Section 6; and
  - **Betty 132H well** with a first take point in the SE/4 NE/4 (Unit H) of said Section 5 and a last take point in SW/4 NW/4 (Unit E) of said Section 6.

4. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from all of the working interest owners in the subject spacing unit.

5. Approval of this application will allow Applicant to obtain a just and fair share of the oil and gas underlying the subject lands, avoid the drilling of unnecessary wells, will prevent waste, and will protect correlative rights.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on April 4, 2024, and, after notice and hearing as required by law, the Division enter an order:

- A. Pooling all uncommitted interests the proposed horizontal well spacing unit;
- B. Designating Permian Resources Operating, LLC (OGRID 372165) as operator of the horizontal well spacing unit and the wells to be drilled thereon;
- C. Authorizing Applicant to recover its costs of drilling, completing, and equipping the wells;
- D. Approving the actual operating charges and costs of supervision while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and

**SELF-AFFIRMED STATEMENT OF CHRIS ASTWOOD**

1. My name is Chris Astwood. I work for Permian Resources Operating, LLC (“Permian”) as a Senior Landman. SPC Resources, LLC (“SPC Resources”) is a wholly owned subsidiary of Permian. Permian closed on the acquisition of SPC Resources in December 2023 with an effective date in September 2023.

2. I have previously testified before the New Mexico Oil Conservation Division as an expert witness. My credentials in petroleum land matters have been accepted by the Division and made a matter of record.

3. I am familiar with the application filed by SPC Resources in this case, and I am familiar with the status of the lands in the subject area.

4. None of the parties in this case have indicated opposition, therefore I do not expect any opposition at the hearing.

5. In this case, SPC Resources seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a standard 635.06-acre, more or less, horizontal well spacing unit comprised of Lots 1-4 and the S/2 N/2 (N/2 equivalent) of irregular Section 5, and Lots 1-5, the SE/4 NW/4, and the S/2 NE/4 (N/2 equivalent) of irregular Section 6, Township 22 South, Range 27 East, NMPM, Eddy County, New Mexico.

6. SPC Resources seeks to initially dedicate the above-referenced horizontal spacing unit to the following proposed wells from a common location SE/4 NE/4 (Unit H) of Section 5:

- **Betty 131H well** with a first take point in the NE/4 NE/4 (Unit A) of said Section 5 and a last take point in NW/4 NW/4 (Unit D) of said Section 6; and
- **Betty 132H well** with a first take point in the SE/4 NE/4 (Unit H) of said Section 5 and a last take point in SW/4 NW/4 (Unit E) of said Section 6.

7. **SPC Exhibit C-1** includes the Form C-102 for the proposed wells. It shows that the wells are located in the Esperanza; Bone Spring Pool (Pool Code 97755) and will comply with the applicable setback requirements. There are no depth severances in the Bone Spring formation in this acreage.

8. **SPC Exhibit C-2** is a plat showing the proposed spacing unit outlined in red. This plat also depicts city blocks and streets. There are several different colors on the map that reflect the status of SPC Resources' efforts to lease each tract within the spacing unit: (1) solid yellow shading reflects tracts leased by SPC; (2) grey shading reflects tracts leased by other working interest owners; and (3) light blue shading reflects unleased tracts that SPC is seeking to force pool in this case.

9. **SPC Exhibit C-3** provides a summary of the percentage of ownership interests in the horizontal spacing unit, in the aggregate, as between the working interests and unleased mineral interests. The second page of the exhibit breaks those interests down by ownership type on a unit basis. **SPC Exhibit C-4** includes the working interest detail and identifies the working interests SPC is seeking pool with an asterisk. SPC is also seeking to pool overriding royalty interest owners identified in the second table with an asterisk. The list of individual unleased

mineral interest owners SPC is seeking to pool is notated as UMI in the worksheet included as **SPC Exhibit C-5**.

10. SPC has made a good faith effort to locate every working interest owner that remains to be pooled. It has maintained detailed mail tracking records reflecting SPC's attempts to contact every working interest owner to provide a well proposal letter together with corresponding AFEs and notice of the pooling hearing via certified mail.

11. The costs reflected in the AFEs are consistent with what other operators have incurred for drilling similar horizontal wells in the area. A copy of an example well proposal letter, along with the AFE, is attached as **SPC Exhibit C-6**.

12. In addition to the well proposal letters, SPC undertook additional good faith efforts to locate and contact each uncommitted working interest owner in this proposed spacing unit. First, SPC started with the last known address of record corresponding to the leasehold owned within the unit. From there, SPC updated corporate addresses using common internet search engines and publicly available sites with phone number and address information. SPC has also maintained detailed records of follow-up emails and phone calls to every working interest owner.

13. SPC has conducted a diligent search of all public records in Eddy County, including phone directories and computer databases to locate each of the parties owning an unleased mineral interest in the proposed spacing unit, which includes hundreds of individual town-lot tracts.

14. SPC's contract land brokerage company, Schoeffler Energy Group ("SEG"), conducted the following research process to identify unleased mineral owners within this spacing unit:

- a. Developed a chain of title for each lot/tract from inception of the records (patent) to current using the records of: (1) Guaranty Title Company title

plant in Carlsbad, NM; (2) Currier Abstract Co. title plant in Artesia, NM; and (3) Eddy County Clerk's records;

- b. Reviewed every conveyance in the chain of title for each lot/tract to identify the mineral owner(s) through time;
- c. Searched each mineral owner(s) name from his/her acquisition of the property to current in the following records: (1) Eddy County Clerk; (2) Eddy County Probate Court Clerk of Eddy County; and (3) Eddy County District Court Clerk; and
- d. If a mineral deed, probate, or other form of conveyance was found while searching the mineral owner(s) names, SPC repeated the third step for all the mineral owner(s) found.

15. Based on the research process described in the preceding paragraph, SEG also prepared Mineral Ownership Reports ("MOR") or Limited Certificate of Title ("LTC") for each interest identified and maintained copies of every MOR/LTC on a tract-by-tract basis in each lease file or unleased mineral interest owner file.

16. SPC identified more than 500 unleased mineral interest owners in the proposed spacing unit. SPC maintains records of its efforts to lease each unleased mineral interest in a file that details the attempts taken to reach/identify each owner and secure a lease. Further, SPC remains ready and willing to lease any unleased mineral interest owners who contact SPC or SEG.

17. To ensure accurate ownership information, SPC also obtained the following:
- a. Title Opinions to current for tracts three (3) acres and larger;

- b. Title Opinions to the last dedication of a subdivision, to limit the risk of a systematic title failure, and then each tract (smaller than three acres) within the subdivision has been brought forward with an MOR or LTC;
- c. Any tract outside of a subdivision, but smaller than three acres is based on an MOR/LTC to current.

18. SPC, working with SEG, initially attempted to locate mineral owners in Carlsbad by knocking on doors and leaving door hangers with information about SPC leasing within the City of Carlsbad (with contact information for SPC's local office). SPC would then send generic offer letters to identified mineral owners to the last known address of record, addresses in the Carlsbad/Eddy County phone book, addresses from the Eddy County Assessor, and various online search tools for address and numbers. SPC also called any numbers found in the phone book or on our online search tools/websites and leave voicemails, if possible. Additionally, SPC searched various websites to identify and contact heirs (or the heirs if deceased). Finally, SPC also hired two residents who have lived in Carlsbad for many years who assisted SPC in finding interest owners.

19. SPC has also worked with the City of Carlsbad to obtain leases of both the private and public interests in the proposed Unit. On October 10, 2017, the City of Carlsbad adopted Ordinance No. 2017-28 authorizing the Granting of an Oil and Gas Lease on certain minerals (mainly streets, roads, alleys and some parks) owned by the City.

20. SPC has undertaken good faith efforts to locate and to reach an agreement with locatable uncommitted interest owners of every tract, and SPC maintains town-lot tract files detailing the attempts taken to identify and contact each owner and secure a lease.



21. SPC will continue to work to reach a voluntary agreement with any of the proposed pooled parties.

22. SPC seeks approval of overhead and administrative costs at \$10,000/month while drilling and \$1000/month while producing. These costs are consistent with what SPC and other operators are charging in this area for these types of wells. SPC respectfully requests that these administrative and overhead costs be incorporated into any order entered by the Division.

23. I provided a list of the parties subject to pooling in this case to the law firm of Holland & Hart LLP.

24. **SPC Exhibits C-1 through C-6** were either prepared by me or compiled under my direction and supervision or constitute company business records.

25. I affirm under penalty of perjury under the laws of the State of New Mexico that the foregoing statements are true and correct. I understand that this self-affirmed statement will be used as written testimony in this case. This statement is made on the date next to my signature below.

1. My name is Tyler Chesworth. I work for Permian Resources Operating, LLC as Senior Geologist. SPC Resources, LLC (“SPC”) is a wholly owned subsidiary of Permian Resources Operating, LLC.

2. I have not previously testified before the New Mexico Oil Conservation Division as an expert witness in petroleum geology. I have attached my resume as **SPC Exhibit D-1** which provides an overview of my education and relevant work experience as a petroleum geologist. I believe my education and experience qualify me to testify as an expert in petroleum geology.

3. I am familiar with the application filed by SPC in this case, and I have conducted a geologic study of the target formation within the subject area.

4. SPC is targeting the Bone Spring formation in this case.

5. **SPC Exhibit D-2** is a locator map that identifies the location of the proposed spacing unit in a red outline within Eddy County. The boundary of the City of Carlsbad is depicted with a light blue outline. The Capitan Reef is depicted with a darker blue outline.

6. **SPC Exhibit D-3** is an overview map depicting our revised plan of development for the Bone Spring in this spacing unit. Upon review, we determined it is prudent to simultaneously co-develop the targeted Lower Bone Spring interval in this spacing with a spacing unit in the Upper Wolfcamp that is the subject of Case No. 24341.

7. **SPC Exhibit D-4** is a subsea structure map that I prepared off the top of the targeted interval in the Bone Spring formation. The horizontal spacing unit is outlined in dark blue. The proposed initial wellbore path is depicted with dashed lines within the spacing unit, as noted in the legend. The map also shows the locations of other producing Bone Spring wells, as indicated on the legend. The contour interval is 100 feet. The structure map shows that the Bone Spring dips gently to the east in this area. The structure appears generally consistent across the proposed spacing unit. I do not observe any faulting, pinch-outs, or other geologic hazards to developing a horizontal well.

8. **SPC Exhibit D-4** also shows the location of two wells used to construct a west-to-east cross-section from A to A'. I consider these wells to be representative of the geology in the area.

9. **SPC Exhibit D-5** is a stratigraphic cross-section prepared by me for the two representative wells from A to A'. The exhibit shows logs for gamma ray, resistivity, and neutron density for each well. The proposed target interval for each initial proposed well is also depicted on the cross-section and identified by well number on the right side of the exhibit. The cross-section demonstrates that the targeted interval within the Bone Spring is generally consistent in thickness across the entire spacing unit.

10. **SPC Exhibit D-6** is gun-barrel diagram depicting our proposed co-development between the Lower Bone Spring interval through the proposed Betty131H and 132H wells in this Case with the proposed Betty 221H-222H wells in Case No. 24341. Simultaneous co-development of the Wolfcamp and Lower Bone Spring formations is expected to increase ultimate recovery of hydrocarbons from both formations, will reduce waste, and protect correlative rights.

11. Based on my geologic study of the Bone Spring formation in the area, I have not identified any geologic impediments to drilling horizontal wells across the spacing unit.

12. In my opinion, the orientation of the proposed well is the preferred orientation for horizontal well development in this area and is appropriate to efficiently and effectively develop the subject acreage.

13. It is also my opinion that each tract comprising the proposed spacing unit in this case will be productive and contribute more-or-less equally to production from the wellbores.

14. Granting SPC's application in this case is in the best interest of conservation, the prevention of waste, and protection of correlative rights.

15. **SPC Exhibits D-1 through D-6** were either prepared by me or compiled under my direction and supervision.

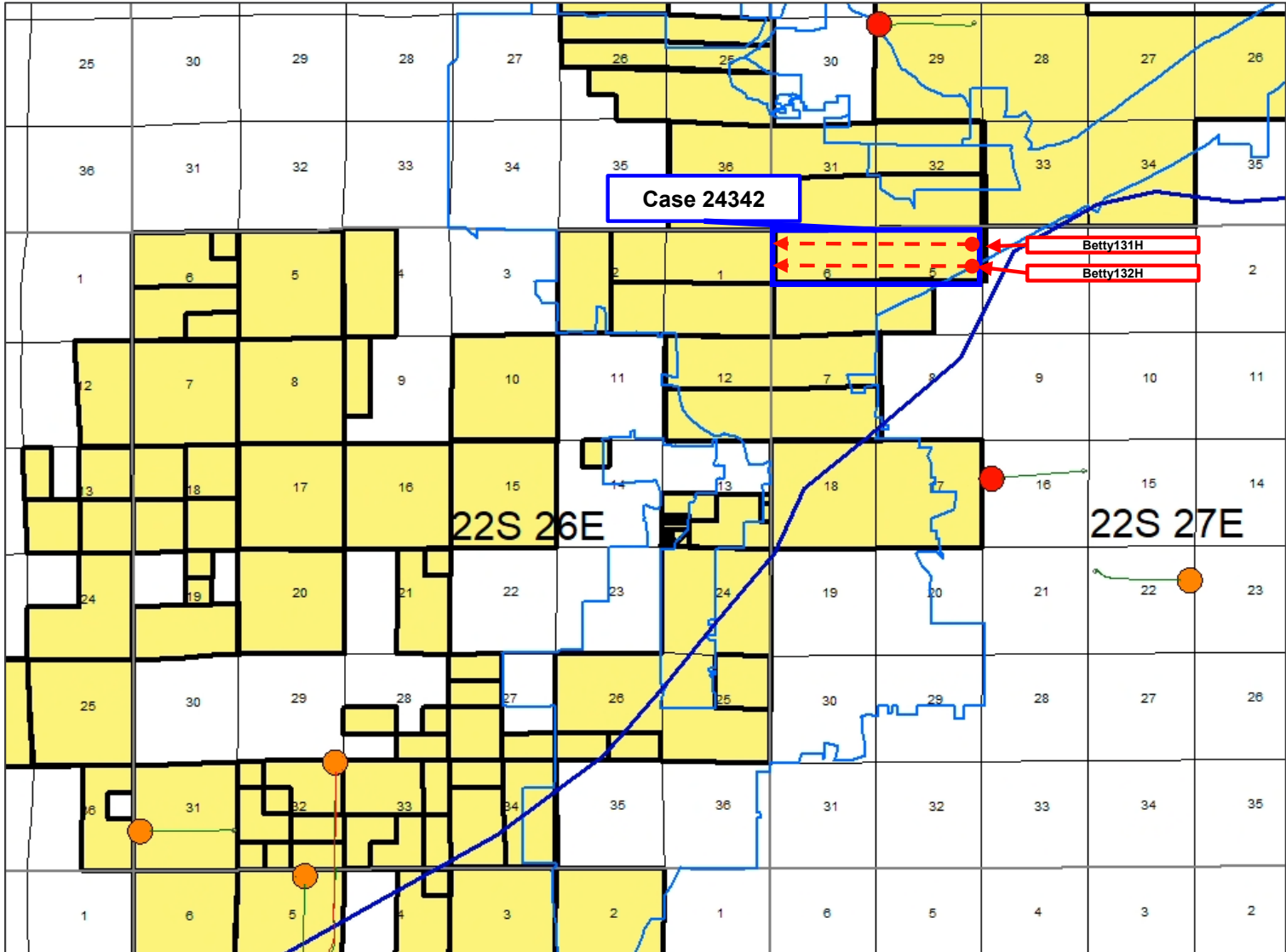

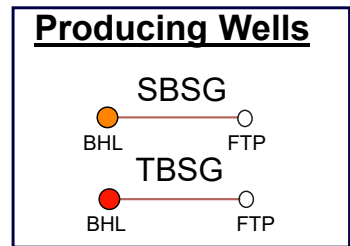
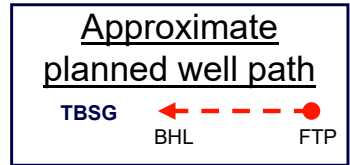
# Cross-Section Locator Map

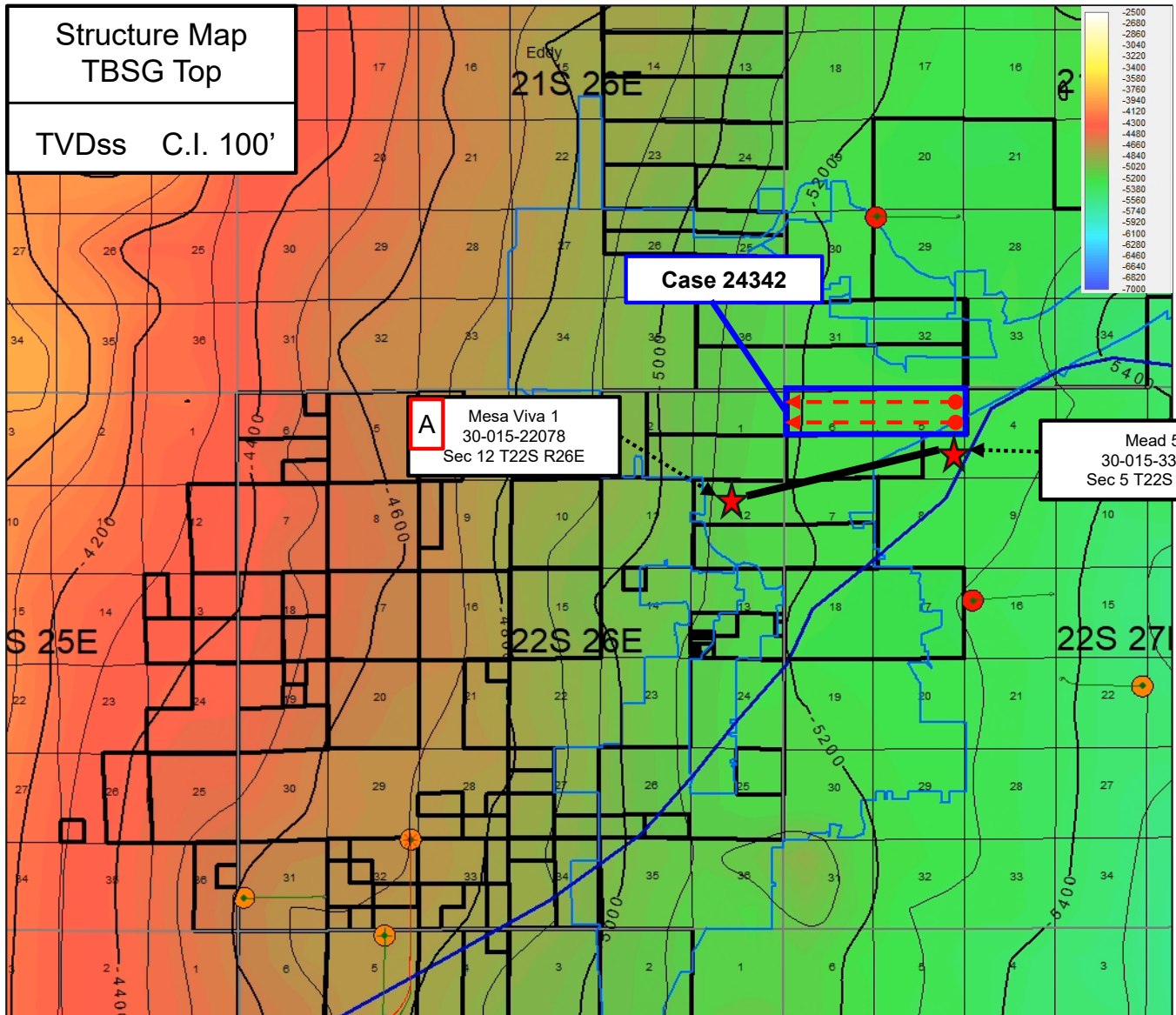

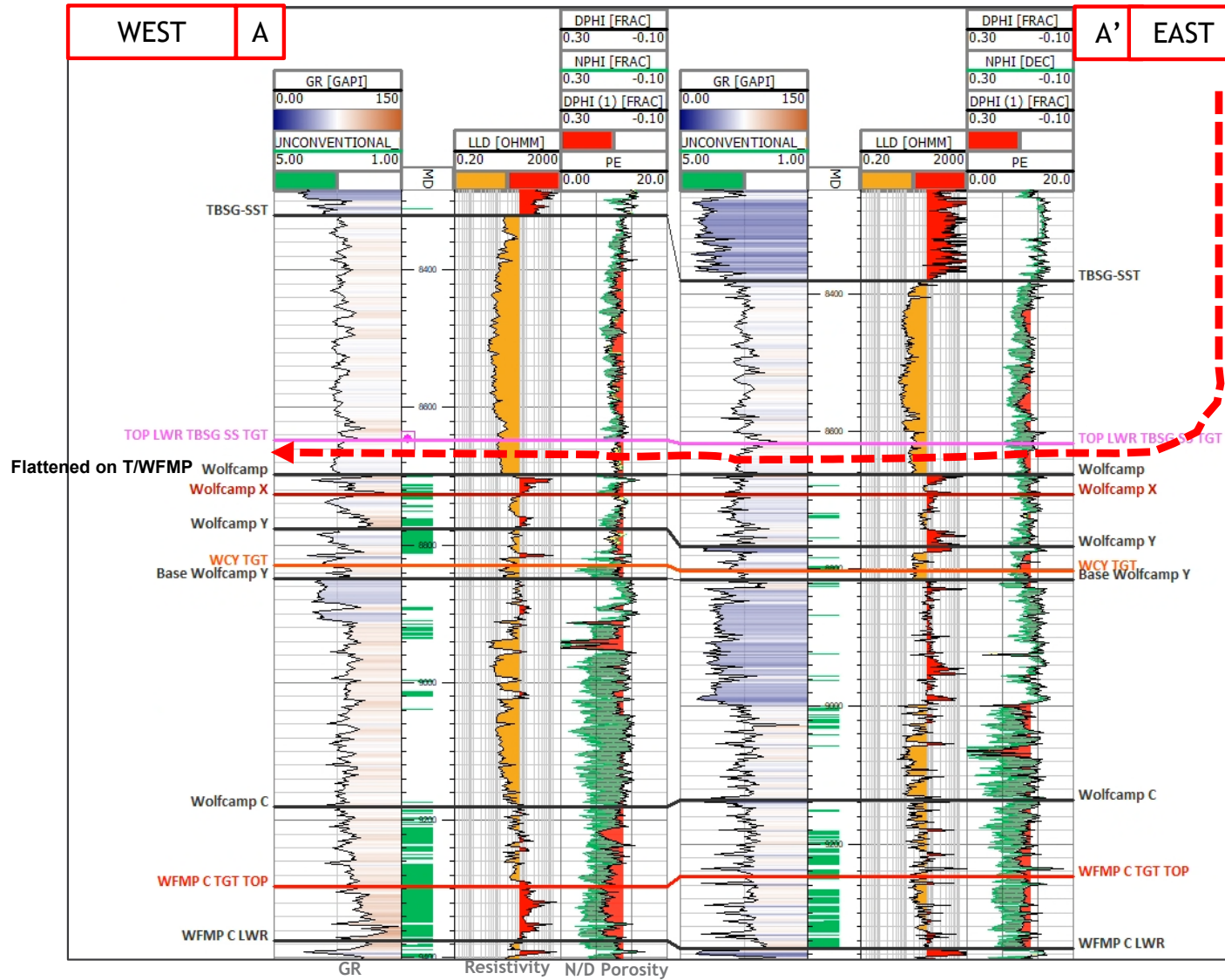

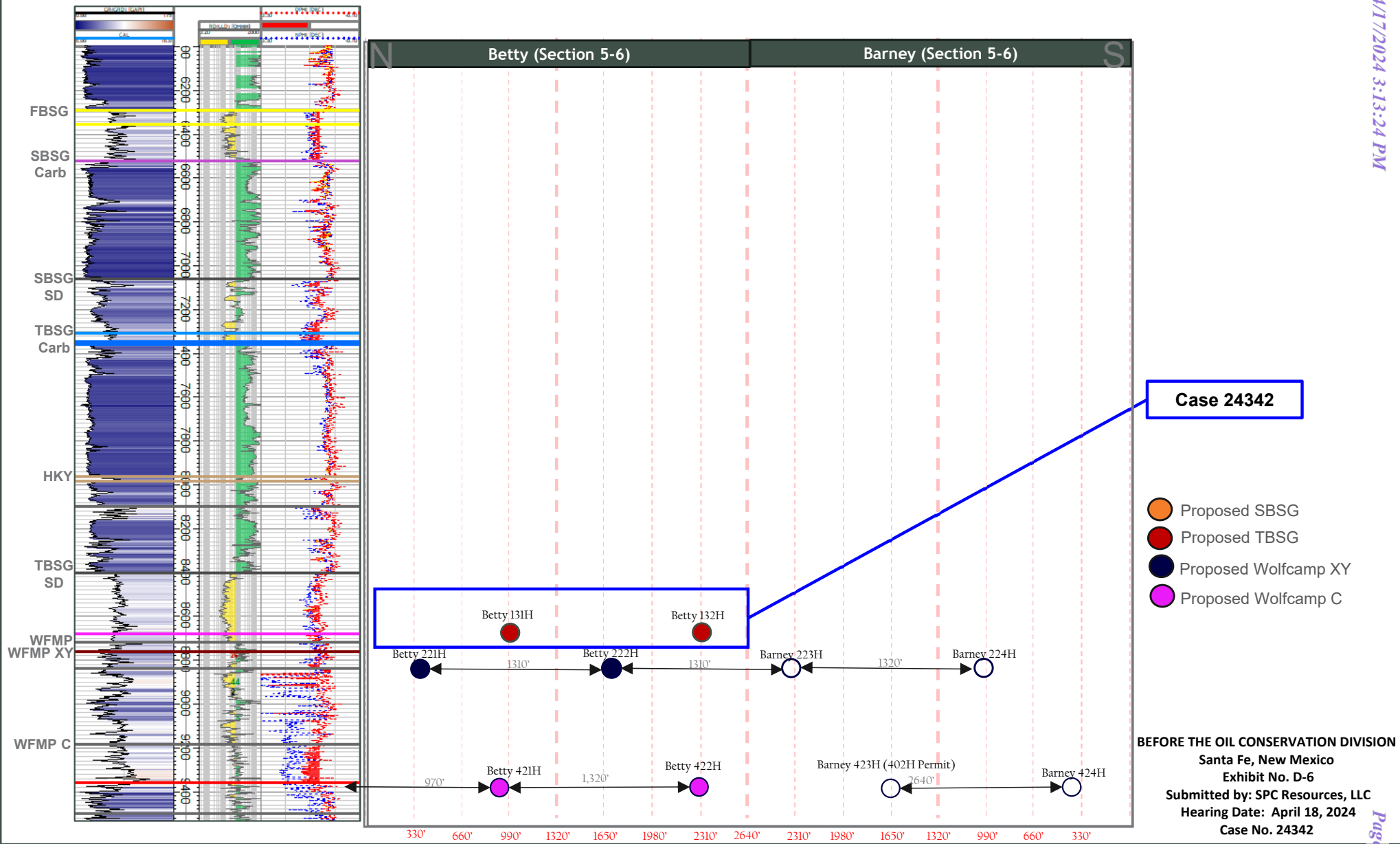
