## STATEMENT OF CASE

## **APPLICANT:**

In Case No. 24183, Marathon seeks an order from the Division pooling all uncommitted mineral interests within a standard 960-acre, more or less, Bone Spring horizontal spacing unit underlying the S/2 of Section 36, Township 22 South, Range 27 East, and the S/2 of Sections 31 and 32, Township 22 South, Range 28 East, NMPM, Eddy County, New Mexico. This spacing unit will be dedicated to the **Blue Barracuda Federal Com 301H** and **Blue Barracuda Federal Com 501H** wells to be horizontally with first take points in the SW/4 SW/4 (Unit M) of Section 36 with last take points in the SE/4 SE/4 (Unit P) of Section 32; and the **Blue Barracuda Federal Com 302H** and **Blue Barracuda Federal Com 502H** wells to be horizontally drilled with first

take points in the NW/4 SW/4 (Unit L) of Section 36 and last take points in the NE/4 SE/4 (Unit I) of Section 32. The producing area for the wells is expected to be orthodox. The completed intervals for the Blue Barracuda Federal Com 302H and Blue Barracuda Federal Com 501H are expected to be less than 330 feet from the adjoining tracts thereby allowing for the inclusion of the proximity tracts within the proposed spacing unit. Also to be considered will be the cost of drilling and completing said wells, the allocation of these costs as well as the actual operating costs and charges for supervision, designation of Marathon as operator of the wells, and a 200% charge for risk involved in drilling said wells. Said area is located approximately 5.45 miles northwest of Loving, New Mexico.
