**UNCONTESTED MOTION TO CONSOLIDATE CASES
AND SET CONTESTED HEARING DATE**

Mewbourne Oil Company (“Mewbourne”) hereby moves the Division to (a) consolidate the above cases for hearing and (b) set a date for a contested hearing, and in support thereof states:

1. Permian Resources Operating LLC (“Permian”) and Mewbourne have filed applications proposing wells in overlapping spacing units in both the Bone Spring and Wolfcamp formations. A summary of the cases is set forth below:

All lands are in Township 22 South, Range 26 East, N.M.P.M.


2. The Permian cases are set for a scheduling conference on June 13th, and the Mewbourne cases are on the June 27th docket

3. At the May 16, 2024 hearing these cases were discussed, and the Division offered four potential hearing dates in the first half of August 2024. Counsel for the parties have conferred and agreed up an August 7, 2024 for a contested hearing on these cases.

4. This motion is unopposed.

WHEREFORE, for the reasons set forth above, Mewbourne asks that the above-referenced cases be consolidated for purposes of a contested hearing on hearing on August 7, 2024.


