APPLICANT’S STATEMENT OF THE CASE

Applicant seeks an order pooling all uncommitted interests in standard 80-acre directional well spacing unit in the Strawn formation [Casey Strawn, West Pool (10330)] underlying the N2SW4 of Section 28, Township 16 South, Range 37 East, NMPM, Lea County, New Mexico. Applicant seeks to initially dedicate the above-referenced spacing unit to its proposed **Ray Baribault No. 1**, a directional well to be drilled and completed at a non-standard location in the NW4SW4 (Unit L) of Section 28 to a depth sufficient to test the Strawn formation.

Applicant seeks to have Matador Production Company (OGRID No. 228937) designated as the operator of these proposed spacing unit and has been unable to obtain voluntary agreement for development of this acreage from all the mineral interest owners.
