APPLICATION

MRC Permian Company (“Applicant”), through its undersigned attorneys, files this application with the Oil Conservation Division pursuant to the provisions of NMSA 1978, § 70-2-17, for an order pooling all uncommitted interests in a standard 80-acre vertical well spacing unit within the Strawn formation underlying the E2SE4 of Section 28, Township 16 South, Range 37 East, NMPM, Lea County, New Mexico. In support of this application, Applicant states:

1. Applicant is an interest owner in the subject acreage and has a right to drill thereon.
2. Applicant seeks to designate Matador Production Company (OGRID No. 228937) as the operator of the proposed spacing units.
3. Applicant seeks to initially dedicate the above-referenced spacing unit to its proposed **Ray Baribault No. 3**, a vertical well to be completed at a non-standard location in the NE4SE4 (Unit I) of said Section 28 to a depth sufficient to test the Strawn formation.
4. This acreage is dedicated to the Casey; Strawn, West Pool (10330), an oil pool subject to the special pool rules issued under Order No. R-8182, *et. seq.* These

special pool rules require 80-acre vertical well spacing and for wells to be located within 150 feet of the center of a governmental quarter-quarter section.

5. Applicant will separately seek administrative approval for the proposed non-standard location.

6. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from all working interest owners in the subject acreage.

7. The pooling of interests will avoid the drilling of unnecessary wells, will prevent waste, and will protect correlative rights.

8. The approval of this application and the pooling of interests will allow Applicant to obtain a just and fair share of the oil and gas underlying the subject lands, avoid the drilling of unnecessary wells, will prevent waste, and will protect correlative rights.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on June 13, 2024, and, after notice and hearing as required by law, the Division enter an order:

- A. Pooling all uncommitted interests within the Strawn formation;
- B. Designating Matador Production Company as the operator of said spacing unit and well;
- C. Authorizing Applicant to recover its costs of drilling, equipping, completing, and recompleting the well;
- D. Approving the actual operating charges and costs of supervision while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and

- E. Imposing a 200% charge for the risk assumed by Applicant in drilling, completing, and equipping the well against any working interest owner who does not voluntarily participate in the drilling of the well.

CASE _____: **Application of MRC Permian Company for Compulsory Pooling, Lea County, New Mexico.** Applicant in the above-styled cause seeks an order pooling all uncommitted interests in a standard 80-acre vertical well spacing unit within the Strawn formation underlying the E2SE4 of Section 28, Township 16 South, Range 37 East, NMPM, Lea County, New Mexico. Applicant seeks to initially dedicate the above-referenced spacing unit to its proposed **Ray Baribault No. 3**, a vertical well to be completed at a non-standard location in the NE4SE4 (Unit I) of said Section 28 to a depth sufficient to test the Strawn formation. Also to be considered will be the cost of drilling, completing, and equipping the well and the allocation of the cost thereof, the actual operating costs and charges for supervision, the designation of Matador Production Company as operator of the well, and a 200% charge for risk involved in drilling, completing and equipping the well. The subject area is located approximately 6.5 miles southeast of Lovington, New Mexico.

SELF-AFFIRMED STATEMENT OF ADDISON COSTLEY

Addison Costley, of lawful age and being first duly sworn, declares as follows:

1. My name Addison Costley. I work for MRC Energy Company, an affiliate of MRC Permian Company (“MRC”), as a Landman.
2. I graduated from Texas Tech University in 2023 with a bachelor’s degree in Energy Commerce. Between May 2022 and March 2023, I interned for Marathon Oil Corporation as a Professional Land Intern. Following graduation, I began working for MRC as a Landman. During my time at MRC, I have worked on MRC’s assets in the Delaware Basin, including Eddy and Lea Counties in New Mexico. My duties and responsibilities as a Landman include conducting land due diligence, acquiring leases, and assisting in the drafting, negotiation and administration of agreements related to MRC’s assets. As part of my employment for MRC, I am also required to complete at least 40 hours of continuing education each year. I am an active member of the American Association of Professional Landmen (AAPL) and the Dallas Association of Professional Landmen (DAPL).
3. I am familiar with the application filed by MRC in this case, and I am familiar with the status of the lands in the subject area.
4. In this case, MRC is seeking an order pooling all uncommitted interests in the Strawn formation in the standard 80-acre, more or less, directional well spacing unit in the Strawn

formation underlying the E/2 SE/4 of Section 28, Township 16 South, Range 37 East, NMPM, Lea County, New Mexico. This standard spacing unit will be initially dedicated to the proposed **Rey Baribault No. 3** well to be vertically drilled and completed at a non-standard location in the NE4SE4 of said Section 28 T16S-R37E to a depth sufficient to test the Strawn formation.

5. MRC understands this well will be placed in the CASEY; STRAWN, WEST [10330] pool.

6. **MRC Exhibit A-1** contains the draft Form C-102 for the proposed well showing the well and the location within the proposed spacing unit.

7. My understanding is that special pool rules under Order No. R-8182, as amended, govern the Casey; Strawn, West pool and (i) set 80 acres as the standard spacing unit size for the directional well planned to be drilled, and (ii) require wells to be located within 150 feet of the center of a governmental quarter-quarter section. MRC will separately file for administrative approval of a non-standard location for the well.

8. **MRC Exhibit A-2** identifies the fee tract of land comprising the proposed spacing unit.

9. **MRC Exhibit A-3** identifies the working interest owners that MRC is seeking to pool along with their respective ownership interest in the proposed spacing unit.

10. There are no depth severances within the Strawn formation for this acreage.

11. **MRC Exhibit A-4** contain an example of the well proposal letters sent to the parties that MRC seeks to pool, along with the AFE sent to working interest owners for each well. The costs reflected in the AFE are consistent with what other operators have incurred for drilling similar vertical wells in the area.

12. **MRC Exhibit A-5** contains a chart of MRC's contacts and attempted contacts with the uncommitted working interest owners MRC seeks to pool. The first column in the chart indicates whether the proposal letters and AFEs were delivered to each party's first potential address or, in certain circumstances, where MRC was unable to locate an address for the party. The second column indicates those parties where the first potential address went undelivered. For the parties identified in the second column, the third column indicates whether MRC was able to locate a second potential address, in which case MRC sent another copy of the proposal to such potential second address. The fourth column indicates those parties where, in addition to sending well proposals, MRC has been able to contact such party by phone or email.


13. MRC attempted to find contact information for each of the working interest owners we seek to pool. These efforts included contracting multiple brokers to conduct searches of public records in the county where the proposed wells are located and online searches for contact information. As shown on Exhibit A-5, despite these efforts, there are a number of owners that MRC has not yet been able to locate and we will continue efforts to find contact information for those owners. In my opinion, MRC has undertaken good faith efforts to contact and reach an agreement with the uncommitted working interest owners that MRC seeks to pool in this case.

14. MRC requests overhead and administrative rates be initially set at \$10,000/month while drilling, and \$1,000/month while producing to be adjusted in accordance with the COPAS guidelines. These costs are consistent with the Joint Operating Agreement for this acreage and consistent with what other operators are charging in this area for these types of wells.

15. I provided MRC's outside counsel, Holland & Hart, a list of names and addresses for the parties that MRC is seeking to pool.

16. **MRC Exhibits A-1 through A-5** were either prepared by me or compiled under my direction and supervision.

17. I affirm under penalty of perjury under the laws of the State of New Mexico that the foregoing statements are true and correct. I understand that this self-affirmed statement will be used as written testimony in this case. This statement is made on the date next to my signature below.

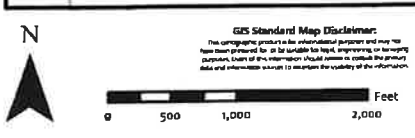
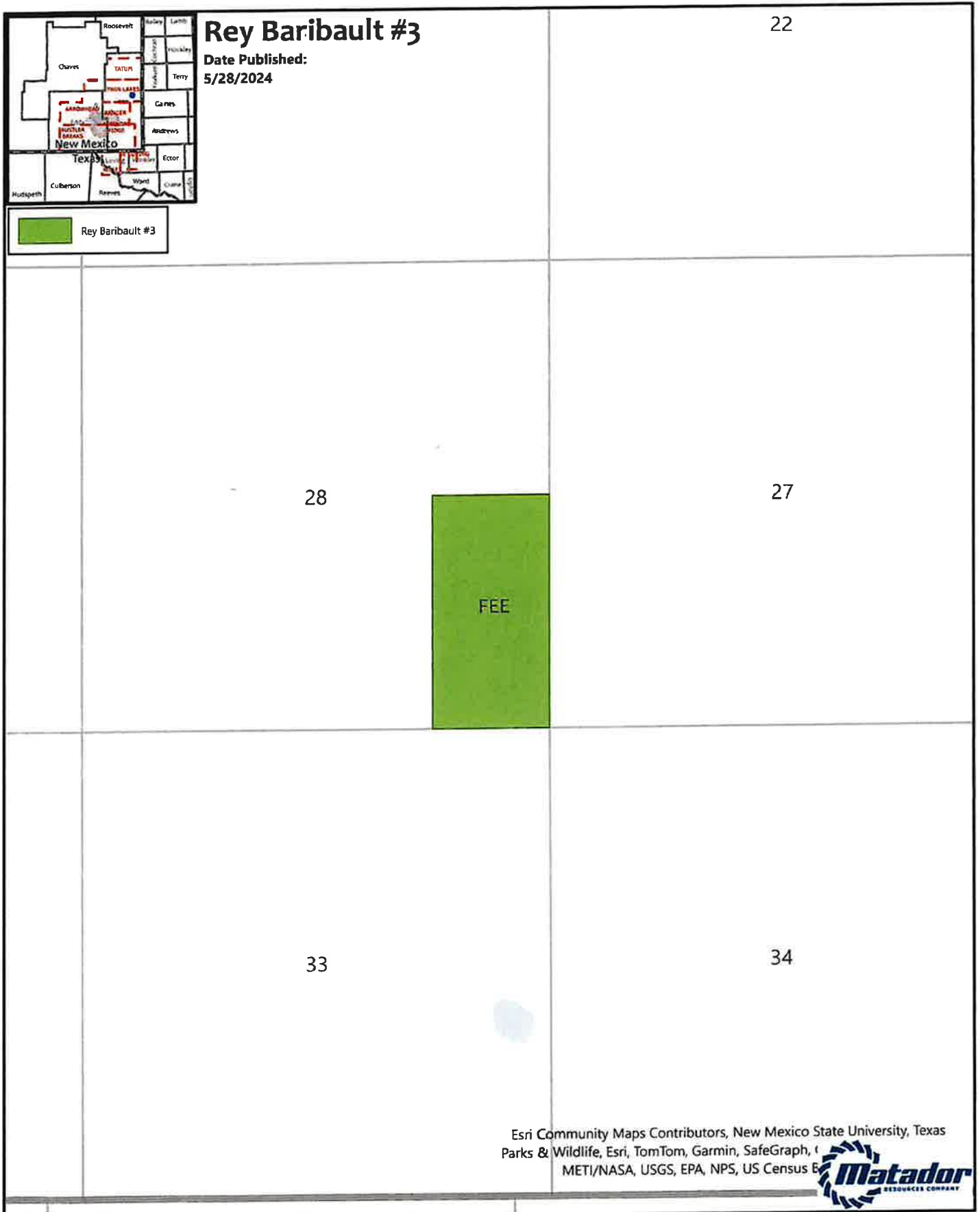

SELF-AFFIRMED STATEMENT OF ANDREW PARKER

Andrew Parker, of lawful age and being first duly sworn, declares as follows:

1. My name is Andrew Parker. I work for MRC Energy Company, an affiliate of MRC Permian Company (“Matador”), as a Senior Vice President of Geoscience.
2. I have previously testified before the New Mexico Oil Conservation Division as an expert witness in petroleum geology. My credentials as a petroleum geologist have been accepted by the Division and made a matter of record.
3. I am familiar with the applications filed by Matador in these cases, and I have conducted a geologic study of the lands in the subject area.
4. **Matador Exhibit B-1** is a locator map identifying the location of the proposed spacing unit within Section 28, Township 16 South, Range 37 East, NMPM, Lea County, New Mexico. A red box identifies the general area where the spacing unit, which is depicted by a yellow rectangle, is located.
5. **Matador Exhibit B-2** is a subsea structure map prepared off the top of the Strawn formation. The contour interval is 50 feet. The proposed bottom-hole location for the Rey Baribault No. 3 well is identified with a red dot. The structure map shows the Strawn formation is relatively flat across the area of the spacing unit but on a regional scale gently dips to the northeast. The

structure appears consistent across the spacing unit. I do not observe any faulting, pinchouts, or other geologic impediments to drilling in this acreage or at the proposed location.

6. Also included on Matador Exhibit B-2 is a line of cross section from A to A'.

7. **Matador Exhibit B-3** is a structural cross-section prepared displaying open-hole logs run over the Strawn formation from four representative wells denoted from A to A'. For each well in the cross-section, the following logs are included: gamma ray, caliper, resistivity, and porosity. The proposed target interval is labeled and marked from the top to the base of the Strawn formation as depicted in the representation of the Rey Baribault No. 3 well in the middle of the cross-section. At the time the well is completed, Matador may choose to selectively complete only a portion of this vertical interval.

8. Matador has identified a discrete reservoir in the spacing unit that it expects will be prospective. The take points for the Ray Baribault No. 3 well are located where Matador believes it can most effectively and efficiently drain the reservoir it has identified within this spacing unit. In my opinion, the proposed location is necessary to prevent waste and protect correlative rights.

9. In my opinion, the proposed vertical well is the most efficient method to develop this acreage, to prevent the drilling of unnecessary wells, and to result in the greatest ultimate recovery.

10. Approving Matador's applications will be in the best interest of conservation, the prevention of waste, and protection of correlative rights.

11. **Matador Exhibits B-1 through B-3** were either prepared by me or compiled under my direction and supervision.

12. I affirm under penalty of perjury under the laws of the State of New Mexico that the foregoing statements are true and correct. I understand that this self-affirmed statement will be

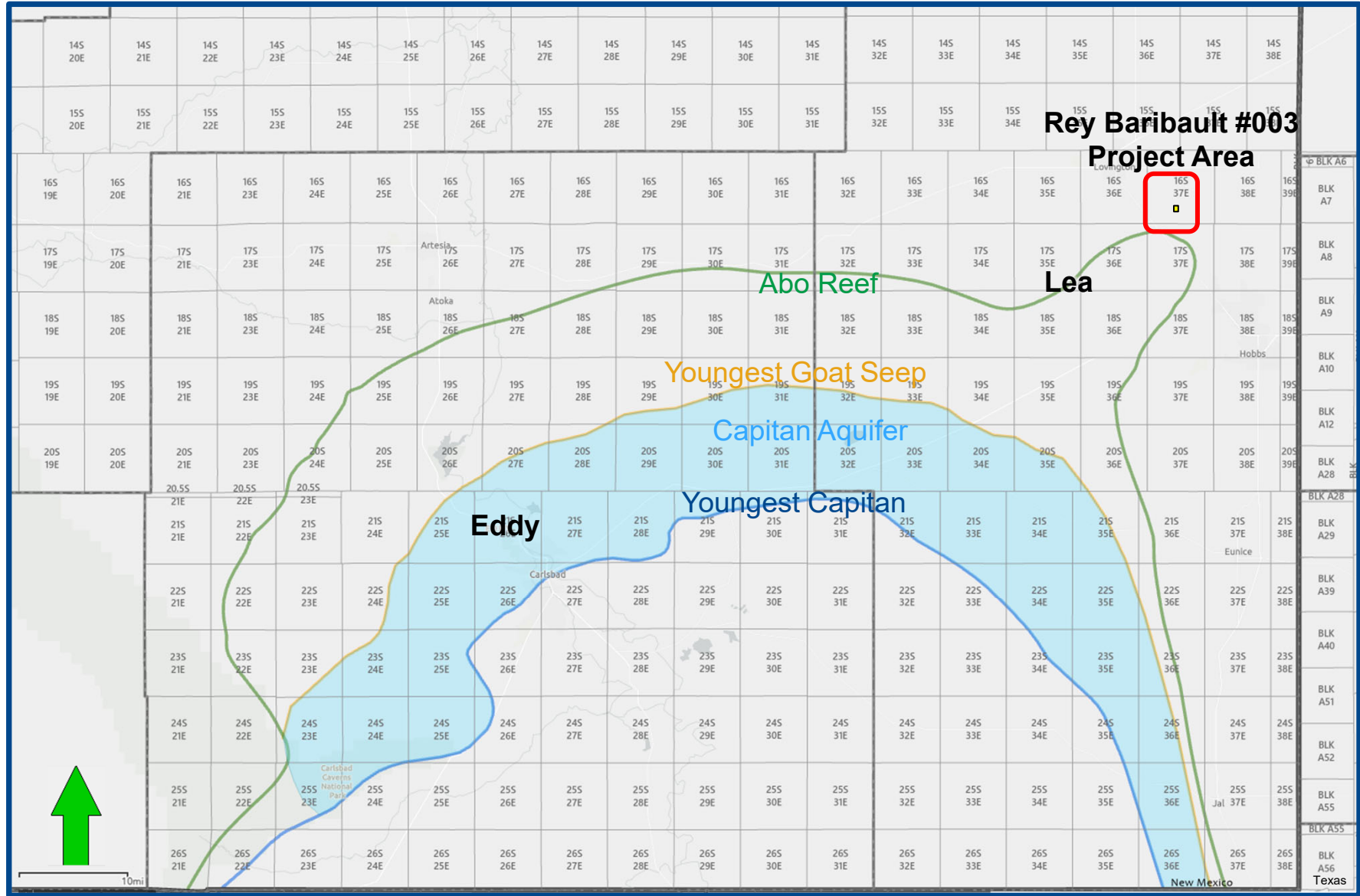

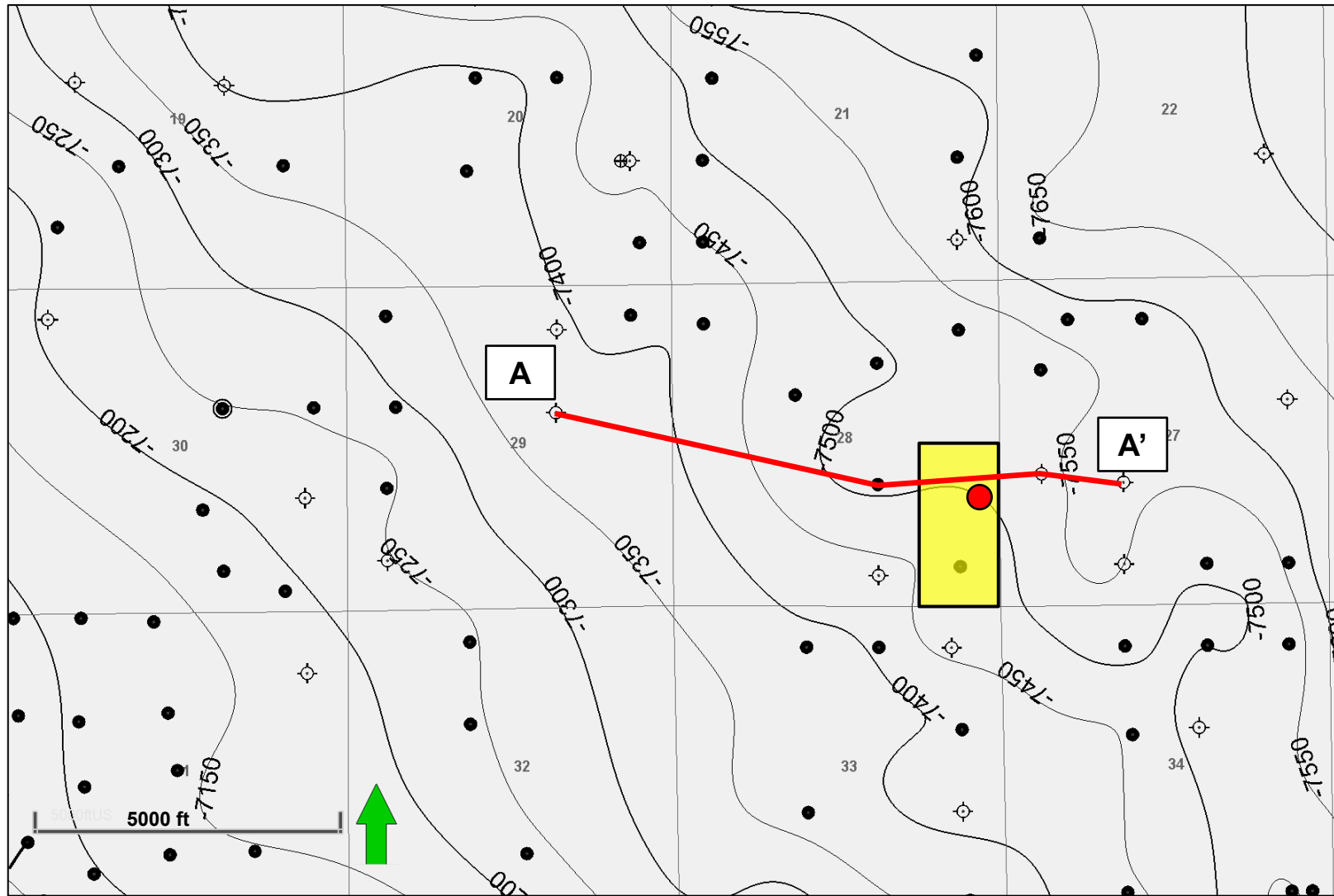

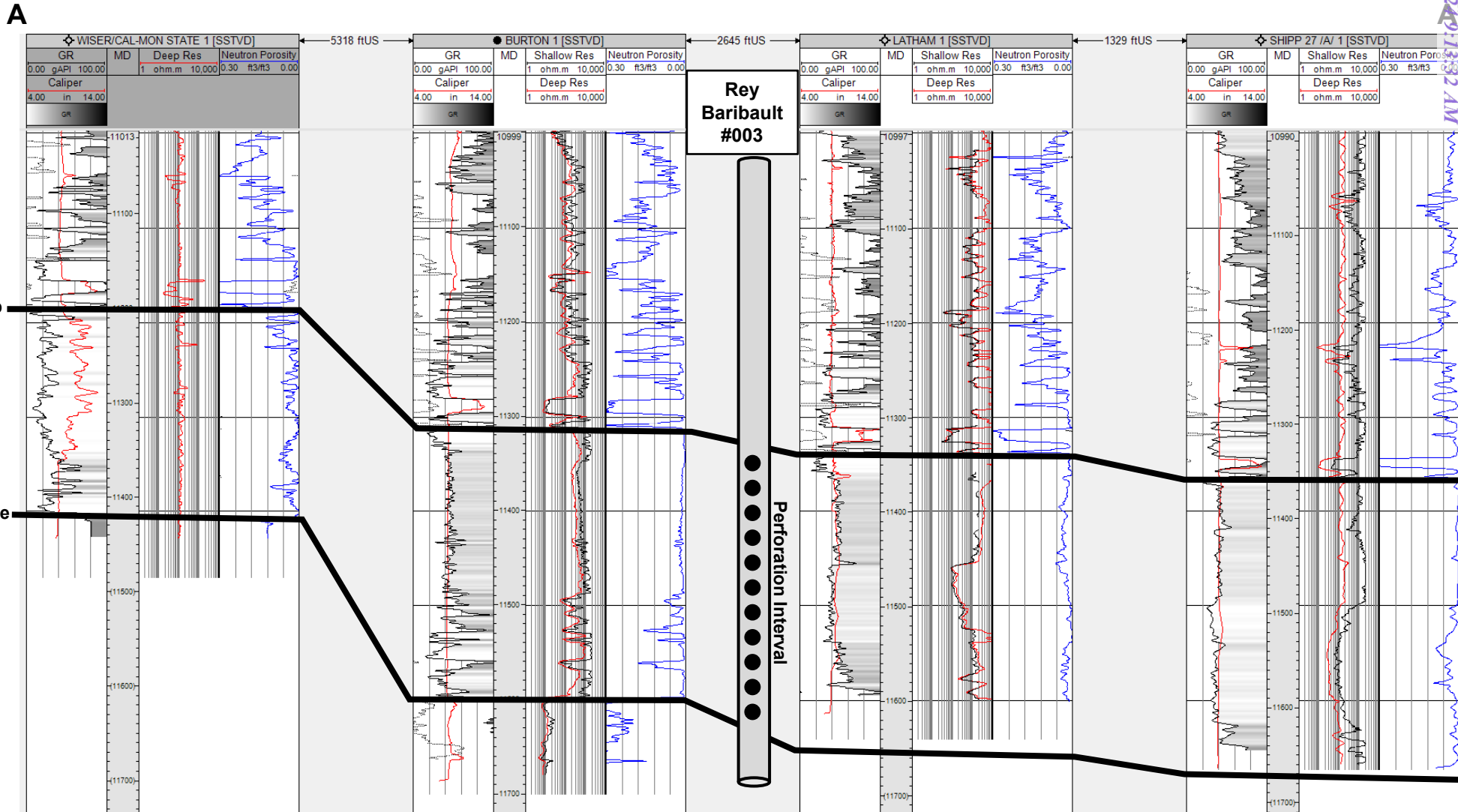
