**APPLICANT’S STATEMENT OF CASE**

In this Case No. 24502, Riley seeks an order adding additional leases and pools to the surface and pool commingling order, approved by Order R-10759-A, for the Eagle “34” Tank Battery located in the NE¼SW¼ (Unit K) of Section 34, Township 17 South, Range 27 East, N.M.P.M., Eddy County, New Mexico. The Application includes a completed Form C-107-B Application for Surface Commingling (Diverse Ownership) to add two additional wells and an additional lease to the surface and pool commingling order approved by Order R-10759-A.

Applicant is the operator of the Northeast Red Lake Glorieta-Yeso Pool and the Red Lake Queen-Grayburg-San Andres Pool underlying United States Oil and Gas Leases NM 056122, LC

026874-B, NM 025528, NM 0557370, LC 064050-A, LC 067849, NM 033865, and NM 29270, which comprise all or parts of Sections 33, 34 and 35, Township 17 South, Range 27 East, N.M.P.M., Eddy County, New Mexico. Applicant seeks to include those portions of United States Oil and Gas Lease NM 0557370, lying outside the existing order and comprising the S/2S/2 of Section 27, Township 17 South, Range 27 East, N.M.P.M., Eddy County, New Mexico. In addition to the lease, Riley requests approval to add two new wells, the Eagle 27 Federal #02 and the Eagle 27 Federal #08, for surface commingling.

In accordance with Rule 19.15.12.10(C)(4)(g) NMAC, Riley requests authorization to include additional pools, leases, or spacing units, within the defined parameters set forth in the Order for future additions.
