STATEMENT OF THE CASES

In Case No. 24503, Applicants seek an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 W/2 of Sections 12 and 13, Township 21 South, Range 34 East, Lea County, New Mexico. The Unit will be dedicated to the **Chokeberry 13-12 State Com #121H** well, which will

produce from a first take point in the SW/4 SW/4 (Unit M) of Section 13 to a last take point in the NW/4 NW/4 (Unit D) of Section 12.

In Case No. 24504, Applicants seek an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Sections 12 and 13, Township 21 South, Range 34 East, Lea County, New Mexico. The Unit will be dedicated to the **Chokeberry 13-12 State Com #122H** well, which will produce from a first take point in the SE/4 SW/4 (Unit N) of Section 13 to a last take point in the NE/4 NW/4 (Unit C) of Section 12.

Applicants each own a working interest in the Units. The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Permian Resources Operating, LLC as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The wells are located approximately 16 miles west of Eunice, New Mexico.
