STATEMENT OF THE CASES

In Case No. 24510, Colgate seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of Sections 17 and 18, Township 20 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the **Esky 17 Fed Com 201H** well, which will be drilled

from a surface hole location in the NE/4 NE/4 (Unit A) of Section 17 to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 18.

In Case No. 24511, Colgate seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 N/2 of Sections 17 and 18, Township 20 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the **Esky 17 Fed Com 202H** well, which will be drilled from a surface hole location in the NE/4 NE/4 (Unit A) of Section 17 to a bottom hole location in the SW/4 NW/4 (Unit E) of Section 18.

In Case No. 24513, Colgate seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 S/2 of Sections 17 and 18, Township 20 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the **Esky 17 Fed Com 203H** well, which will be drilled from a surface hole location in the NW/4 SW/4 (Unit L) of Section 17 to a bottom hole location in the NW/4 SW/4 (Unit L) of Section 18.

In Case No. 24514, Colgate seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 S/2 of Sections 17 and 18, Township 20 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the **Esky 17 Fed Com 204H** well, which will be drilled from a surface hole location in the SW/4 SW/4 (Unit M) of Section 17 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 18.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Permian

Resources Operating, LLC as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The wells are located approximately 16 miles west of Eunice, New Mexico.
