**APPLICANT’S STATEMENT OF THE CASE**

Under **Case No. 24540**, EOG seeks an order pooling all uncommitted interests in the Wolfcamp formation (WC-025 G-09 S233216K; Upr Wolfcamp [98166]) underlying a non-standard 1,920-acre, more or less, horizontal well spacing unit comprised of Sections 20, 29, and 32, Township 22 South, Range 32 East, NMPM, Lea County, New Mexico. This spacing unit will be initially dedicated to the **Pretty Good 20 Fed Com #701H** and **Pretty Good 20 Fed Com #702H** wells, both to be horizontally drilled from a surface location in the NW/4 NE/4 (Unit B) of

Section 20, with a first take point in the NE/4 NE/4 (Unit A) of Section 20, and the last take point in the SE/4 SE/4 (Unit P) of Section 32; **Pretty Good 20 Fed Com #703H** and **Pretty Good 20 Fed Com #704H** wells, both to be horizontally drilled from a surface location in the NW/4 NE/4 (Unit B) of Section 20, with a first take point in the NW/4 NE/4 (Unit B) of Section 20, and the last take point in the SW/4 SE/4 (Unit O) of Section 32; **Pretty Good 20 Fed Com #705H**, **Pretty Good 20 Fed Com #713H**, **Pretty Good 20 Fed Com #743H** wells, all to be horizontally drilled from a surface location in the NW/4 NE/4 (Unit B) of Section 20, with a first take point in the NE/4 NW/4 (Unit C) of Section 20, and the last take point in the SE/4 SW/4 (Unit N) of Section 32; and **Pretty Good 20 Fed Com #707H**, **Pretty Good 20 Fed Com #714H**, **Pretty Good 20 Fed Com #715H**, and **Pretty Good 20 Fed Com #744H** wells, all to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 20, with a first take point in the NW/4 NW/4 (Unit D) of Section 20, and the last take point in the SW/4 SW/4 (Unit M) of Section 32.

EOG proposes to drill certain initial wells within one year of the issuance of a pooling order and drill the remaining initial wells within two years of the issuance of a pooling order.

Applicant filed a separate administrative application for approval of the non-standard spacing unit.

The completed interval for the wells will comply with statewide setbacks for oil wells. EOG has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject acreage.
