APPLICATION

Matador Production Company (“Matador” or “Applicant”), through its undersigned attorneys, hereby files this application with the Oil Conservation Division to add record title owners under Order No. R-20729 (“Pooling Order”). In support of its application, Matador states:

1. On July 31, 2019, the Division entered Order No. R-20729, pooling the uncommitted interest owners in the Upper Wolfcamp formation (Burton Flat; Upper Wolfcamp, East (oil) [98315]) underlying a 155.39-acre, more or less, horizontal well spacing unit comprised of the N/2 SE/4, the NE/4 SW/4, and Lot 3 (NW/4 SW/4 equivalent) of Section 19, Township 20 South, Range 29 East, NMPM, Eddy County, New Mexico. Matador is the designated operator under the Pooling Order and the pooled spacing unit is initially dedicated to the drilled and producing **Stebbins 19 Fed Com 203H** (API No. 30-015-44173) well.

2. Applicant requests that Order R-20729 be re-opened and amended to add additional pooled parties under the Pooling Order.

3. Applicant has sought and been unable to obtain the signatory approval on the federal comunization agreement from the following record title owners: 2012 DCB3 Southwestern IRR Trust; Amsler Young Priddy, Trustee; Becky R. Cooper; D’Arcy Petroleum,

LLC; Highland (Texas) Energy Company; Locke Funds II, LP; Michael Irwin Welch; Veritas; Stacy Welch Green; Trigg Oil & Gas, LP; and Vladin, LLC.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on July 11, 2024, and, after notice and hearing, enter an order placing these additional mineral owners under the terms of Order No. R-20729.

Applicant in the above-styled cause seeks to add record title owners under Order No. R-20729. Order No. R-20729 designated Matador Production Company as the operator and pooled the uncommitted interest owners in the Upper Wolfcamp formation (Burton Flat; Upper Wolfcamp, East (oil) [98315]) underlying a 155.39-acre, more or less, horizontal well spacing unit comprised of the N/2 SE/4, the NE/4 SW/4, and Lot 3 (NW/4 SW/4 equivalent) of Section 19, Township 20 South, Range 29 East, NMPM, Eddy County, New Mexico. This standard horizontal well spacing unit is currently initially dedicated to the drilled and producing **Stebbins 19 Fed Com 203H** (API No. 30-015-44173) well, horizontally drilled from a surface location in the NE/4 SE/4 (Unit I) of Section 19, with a first take point in the NE/4 SE/4 (Unit I) of Section 19 and a last take point in Lot 3 (NW/4 SW/4 equivalent) of Section 19. Said area is located approximately 12 miles northeast of Carlsbad, New Mexico.
