1. On October 15, 2019, the Division entered Order No. R-20925, pooling the uncommitted interest owners in the Upper Wolfcamp formation (Burton Flat; Upper Wolfcamp, East (oil) [98315]) underlying a 316.34-acre, more or less, horizontal well spacing unit comprised of the N/2 N/2 of Section 29, and the N/2 NE/4, the NE/4 NW/4, and Lot 1 (NW/4 NW/4 equivalent) of Section 30, Township 20 South, Range 29 East, NMPM, Eddy County, New Mexico. Matador is the designated operator under the Pooling Order and the pooled spacing unit is initially dedicated to the drilled and producing **Leatherneck 3029 Fed Com 205H** (API No. 30-015-45983) well.

2. Applicant requests that Order R-20925 be re-opened and amended to add additional pooled parties under the Pooling Order.

3. Applicant has sought and been unable to obtain the signatory approval on the federal communization agreement from the following record title owners: 2019 Permian Basin JV; Michael Irwin Welch; Santo Legado, LLC; Sharbro Energy, LLC; Yates Industries, LLC.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on July 11, 2024, and, after notice and hearing, enter an order placing these additional mineral owners under the terms of Order No. R-20925.
