**ENTRY OF APPEARANCE AND  
NOTICE OF INTERVENTION**

Miguel A. Suazo, Sophia A. Graham, and Kaitlyn A. Luck of Beatty & Wozniak, P.C., hereby enter their appearances on behalf of Pilot Water Solutions SWD, LLC (“Pilot”) in the above-referenced matter, pursuant to 19.15.4.10 and 19.15.4.11 NMAC. As an interested party in the proceedings, Pilot intervenes in these cases and states:

1. Empire New Mexico, LLC is an oil-and-gas production company that operates the Eunice Monument South Unit (“EMSU”). The EMSU is an oil-and-gas production area subject to a unitization order issued under the Statutory Unitization Act, NMSA 1978 §§ 70-7-1 through -21, that includes the Grayburg formation and the San Andres formation underlying the EMSU.

2. Pilot is a salt water disposal company that is the designated operator of injection wells within the EMSU that are injecting into the San Andres formation, authorized by Oil Conservation Division injection permits issued pursuant to 19.15.24 NMAC,

3. Pilot’s injection permits into the San Andres formation may be adversely affected by any decision or order of the Commission issued during the proceedings which are the subject of the applications in these cases.

4. In Case No. 24432 before the Oil Conservation Division, Empire filed an Application to Revoke the Injection Authority Granted Under Administrative Order SWD-1750 for the P 15 #001 Well Operated by OWL SWD Operating, LLC, Lea County, New Mexico; OWL SWD Operating, LLC is an affiliate of Pilot.

5. Empire also filed a Complaint against Pilot in State of New Mexico Fifth Judicial District Court Case No. D-506-CV-2024-0377 related to its ownership of the EMSU and Pilot’s subsurface interests in its injection wells that are injecting into the San Andres formation.

6. Due to Pilot’s interests in the San Andres formation and potential adverse implications to its disposal wells, Pilot seeks to intervene to preserve its rights that may be adversely affected by any disposition of these cases involving a determination regarding the San Andres formation.
