STATEMENT OF THE CASE

In these consolidated cases, MRC seeks orders pooling two standard 320-acre horizontal well spacing units in the Bone Spring formation underlying the S2 of Sections 32 and 33, Township 17 South, Range 30 East, NMPM, Eddy County, New Mexico, as follows:

- Under **Case 24322**, MRC seeks to pool the N2S2 of Sections 32 and 33 to be initially dedicated to the proposed **Coach Joe 3332 Fed Com 123H** well to be horizontally drilled from a surface location in the SW4 of Section 34, with a first take point in the NW4SE4 (Unit I) of Section 33 and a last take point in the NW4SW4 (Unit L) of Section 32.
- Under **Case 24323**, MRC seeks to pool the S2S2 of Sections 32 and 33 to be initially dedicated to the proposed **Coach Joe 3332 Fed Com 124H** well to be horizontally drilled from a surface location in the SW4 of Section 34, with a first take point in the SE4SE4 (Unit P) of Section 33 and a last take point in the SW4SW4 (Unit M) of Section 32.

MRC has sought but been unable to obtain a voluntary agreement with all the affected mineral interest owners for the development of the subject acreage.
