These pooling applications were filed in March of 2024 and involve competing development plans for all or parts of Sections 23, 26 and 35, Township 18 South, Range 34 East, and Section 2 of Township 19 South, Range 34 East, NMPM, Lea County New Mexico. The Applicants have recently reached an agreement in principle that will resolve the competing development plans and allow any necessary pooling by Franklin Mountain to proceed in an uncontested fashion. MRC therefore does not intend to present evidence at the scheduled hearing but will maintain its competing applications of record until the agreement between the parties has

been finalized. MRC has separately filed a notice of withdrawal of objection to the Franklin Mountain applications proceeding by affidavit or self-affirmed statements.
