APPLICATION

Riley Permian Operating Company, LLC (“Riley” or “Applicant”) (OGRID No. 372290), the Applicant in the above-referenced case, by and through its undersigned attorneys of Beatty & Wozniak, P.C., filed this application with the Oil Conservation Division (“Division”) for an order adding additional leases and pools to the surface and pool commingling order approved by Order R-10759-A for the Eagle “34” Tank Battery located in the NE¼SW¼ (Unit K) of Section 34, Township 17 South, Range 27 East, N.M.P.M., Eddy County, New Mexico. In support of this application, Riley states:

1. As authorized by Order No. R-10759-A, Applicant seeks continued approval to commingle Northeast Red Lake Glorieta-Yeso Pool and Red Lake Queen-Grayburg-San Andres Pool production from its wells located on the leases and to authorize the allocation of production from these diversely owned wells on the basis of periodic well tests. All production from these wells is to be stored at the Eagle 34 Tank Battery.
2. The Application includes a completed Form C-107-B Application for Surface Commingling (Diverse Ownership) to add two additional wells and an additional lease to the surface and pool commingling order approved by Order R-10759-A.

3. Applicant is the operator of the Northeast Red Lake Glorieta-Yeso Pool and the Red Lake Queen-Grayburg-San Andres Pool underlying United States Oil and Gas Leases NM 056122, LC 026874-B, NM 025528, NM 0557370, LC 064050-A, LC 067849, NM 033865, and NM 29270, which comprise all or parts of Sections 33, 34 and 35, Township 17 South, Range 27 East, N.M.P.M., Eddy County, New Mexico.
4. Applicant seeks to include those portions of United States Oil and Gas Lease NM 0557370, lying outside the existing order and comprising the S/2S/2 of Section 27, Township 17 South, Range 27 East, N.M.P.M., Eddy County, New Mexico.
5. In addition to the lease, Riley requests approval to add two new wells, the Eagle 27 Federal #02 and the Eagle 27 Federal #08, for surface commingling.
6. Royalty interest ownership under the subject leases is common but overriding royalty interest and/or working interest ownership varies.
7. The Application indicates notice was provided as required by Rules 19.15.12.10(C)(4) and 19.15.4.12 NMAC.
8. In accordance with Rule 19.15.12.10(C)(4)(g) NMAC, Riley requests authorization to include additional pools, leases, or spacing units, within the defined parameters set forth in the Order for future additions.
9. Approval of the Application will result in efficient production, storage, and measurement operations for the subject leases; lessens the impact on the surface estate; and is otherwise in the best interest of conservation, the prevention of waste, and the protection of correlative rights.
10. Riley requests this matter be set for hearing before a Division Examiner. Notice of the filing of this application and the administrative application has been provided to the interested parties by certified mail through its counsel of record.

WHEREFORE, Riley requests the Division set this matter for hearing before an Examiner of the Oil Conservation Division on June 13, 2024, and that after notice and hearing the Division enter an order amending Order R-10759-A to include the additional lease and wells identified in the Application for surface and pool commingling at the Eagle "34" tank battery.

Ladies and Gentlemen:

As stated in the Application, Riley Permian Operating Company, LLC ("Riley") requests approval to expand authority granted in Order No. R-10759-A, to include those portions of United States Oil and Gas Lease NM 0557370 ("Lease NM 0557370"), lying outside the existing order and comprising the S/2S/2 of Section 27, Township 17 South, Range 27 East, N.M.P.M., Eddy County, New Mexico. Portions of Lease NM 0557370 are already included in the existing commingling order. The underlying Order No. R-10759-A is attached for your convenience as Exhibit 1.

Riley further requests approval to add two new wells, the Eagle 27 Federal #02 and the Eagle 27 Federal #08, for surface commingling, which are located on Lease NM 0557370.

The Application includes a lease and well data spreadsheet, Exhibit 2, detailing the existing and proposed leases and wells, along with pool codes and current production data.

Exhibit 3 is a detailed schematic, which shows the tank battery as it currently exists along with the equipment that we expect to utilize to determine well production from each lease.

A plat is also enclosed as Exhibit 4, showing the lease numbers and location of all leases and wells that will contribute production to the proposed commingled facility. The Eagle "34" Tank Battery is located on Federal Lease #NMLC67849 in the NE¼SW¼ (Unit K) of Section 34, Township 17 South, Range 27 East, N.M.P.M., Eddy County, New Mexico.


Process and Flow Description: The common gas sales meter will be located at the Eagle "34" Tank Battery. Gas from these wells will be flowed up the casing and measured at each well location with a portable trailer mounted gas meter. Oil and water will be produced via the tubing and go to a header system at the tank battery. Individual wells will be periodically switched into the test treater. From there, oil will go to a test tank where it can be measured, and water production will be metered. All oil will then be sold and trucked from the location.

Production Allocation: Production allocation will be based on the periodic well tests, as described above. Gas allocation will be based on the portable meter tests, oil allocation will be based on the treater test.

The proposed commingling of production is to reduce operating expense on the referenced wells. This will result in increased economic life on each well. This commingling will not result in reduced royalty or improper measurement of production and will not decrease the value of production.

All working interest and overriding royalty owners, including BLM, have been notified in writing of this Application. Through our counsel, Riley has sent the owners Notice Letters dated May 1, 2024, along with the Application and the corresponding attachments via U.S. Postal Service Certified Mail. In the Notice Letters, Riley advised the interest owners on how they may file an objection with the New Mexico Oil Conservation Division. A sample Notice Letter, along with the owners and their addresses, have been included for your convenience, labeled Exhibit 5.

ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing on March 2, 2006 at 8:15 a.m. at Santa Fe, New Mexico, before Examiner Richard I. Ezcanyim.

NOW, on this 21st day of March, 2006, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

(1) Due public notice has been given, and the Division has jurisdiction of this case and of the subject matter.

(2) By Order No. R-10759 issued in Case No. 11693 on February 3, 1997, the Division approved the application of Devon Energy Corporation (Nevada), to commingle production from the Red Lake Queen-Grayburg-San Andres Pool from six Federal Leases namely: NM 025528, NM 056122, LC 026874-B, NM 0557370, LC 067849, and LC 064050-A into a common tank battery located in the NE/4 SW/4 (Unit K) of Section 34 (the Eagle "34" Tank Battery), allocating production to each well and to each lease on the basis of monthly well tests.

(3) The applicant, Devon Energy Production Company, L.P. ("Devon" or "Applicant"), now seeks to expand the authority granted by Order No. R-10759 to add two new Federal leases to the existing six Federal leases, and to permit the commingling of production from the Red Lake-Queen-Grayburg-San Andres Pool and the Northeast Red Lake-Glorieta-Yeso Pool from the eight federal leases described below into the Eagle "34" Tank Battery located in the NE/4 SW/4 (Unit K) of Section 34, Township 17 South, Range 27 East, NMPM, Eddy County, New Mexico.

Leases to be added:

- (a) Federal Lease NM 033865 comprising the N/2 SE/4 of Section 33;
- (b) Federal Lease NM 29270 comprising the SE/4 SE/4 of Section 34.

Existing Leases:

- (c) Federal Lease NM 025528 comprising the N/2 NE/4, SW/4 NE/4, and S/2 SE/4 of Section 33;
- (d) Federal Lease NM 056122 comprising the SE/4 NE/4 of Section 33;
- (e) Federal Lease LC 026874-B comprising the SE/4 SW/4 of Section 33;
- (f) Federal Lease NM 0557370 comprising the NE/4 and NW/4 SE/4 of Section 34;
- (g) Federal Lease NM LC 064050-A comprising the E/2 NW/4 and NE/4 SE/4 of Section 34 and NW/4 SW/4 of Section 35;
- (h) Federal Lease LC 067849 comprising the W/2 NW/4 and SW/4 of Section 34; and

The expanded area will cover approximately 1000 acres, more or less, and the expanded authority will apply to 58 existing and planned wells.

(4) The royalty interest on all leases is 1/8, and belongs to the United States of America. Applicant is the largest working interest owner in all of the leases. Occidental Permian Ltd. owns working interests as to certain depths in all leases except Federal Leases NM 033865 and LC 026874-B; Chesapeake Energy Corporation owns working interests as to certain depths in Federal Leases NM 025528 and NM 033865; and Yates Petroleum Corporation owns a working interest in Federal Lease NM 033865. Overriding royalty ownership is diverse in some of the leases.

(5) Applicant testified that production would be allocated to each well and to each lease on the basis of monthly well tests. In addition, production shall be allocated to each well based on the number of days each month a well produces.

(8) Production from the Red Lake-Queen-Grayburg-San Andres Pool and the Northeast Red Lake-Glorieta-Yeso Pool will be downhole commingled in certain wells. Downhole commingling in those pools is pre-approved by Division Rule 303.C.

(7) Division Rule 303.B.4(a) contains provisions that require the separate metering of production from each lease when leases of diverse ownership are to be commingled.

(8) Each mineral interest owner (working, royalty, and overriding royalty) within the 1000-acre area was provided notice of the application. Only Occidental Permian Ltd. entered an appearance in this matter, and did not object to the application. In addition, the United States Bureau of Land Management has approved the lease commingling.

(9) Approval of this application will result in economic savings to the operator, is in the best interests of conservation, exhibits sound engineering principles, and will serve to prevent waste and protect correlative rights.

(10) The commingling facilities should be operated in accordance with the applicable provisions of Division Rule 303.

IT IS THEREFORE ORDERED THAT:

(1) The Applicant, Devon Energy Production Company, L.P., is hereby authorized to surface commingle Red Lake-Queen-Grayburg-San Andres Pool and the Northeast Red Lake-Glorieta-Yeso Pool production from the following leases described below in Township 17 South, Range 27 East, N.M.P.M., Eddy County, New Mexico in a common, existing tank battery located in the NE/4 SW/4 (Unit K) of Section 34, Township 17 South, Range 27 East, N.M.P.M.

Leases to be added:

(a) Federal Lease NM 033865 comprising the N/2 SE/4 of Section 33;

(b) Federal Lease NM 29270 comprising the SE/4 SE/4 of Section 34;

Existing Leases:

(c) Federal Lease NM 025528 comprising the N/2 NE/4, SW/4 NE/4, and S/2 SE/4 of Section 33;

(d) Federal Lease NM 056122 comprising the SE/4 NE/4 of Section 33;

(e) Federal Lease LC 026874-B comprising the SE/4 SW/4 of Section 33;

(t) Federal Lease NM 0557370 comprising the NE/4 and NW/4 SE/4 of Section 34;

(g) Federal Lease NM LC 064050-A comprising the E/2 NW/4 and NE/4 SE/4 of Section 34 and NW/4 SW/4 of Section 35; and

(h) Federal Lease LC 067849 comprising the W/2 NW/4 and SW/4 of Section 34; and

PROVIDED HOWEVER THAT: The facilities for said commingling of production shall be installed and maintained in a manner that will permit a determination of the production capacity of each of the wells on the subject leases at least once a month.

PROVIDED FURTHER THAT: The commingling facilities shall be installed and operated in accordance with the applicable provisions of Division Rule 303.

PROVIDED FURTHER THAT: Applicant shall conduct monthly productivity tests on each of the wells on the subject leases and shall file the results of said tests with the Division on Division Form C-115 each month.

PROVIDED FURTHER THAT: Applicant shall allocate production to each well based on the number of days each month a well produces.

(2) The operator shall notify the supervisor of the Artesia District Office of the Division prior to implementation of the commingling process, and at such time as wells are completed and production from said wells is included to the facility.

(3) It will be the responsibility of the operator to notify the transporter of this commingling authority.

(4) This Order No. R-10759-A supersedes Order No. R-10759.



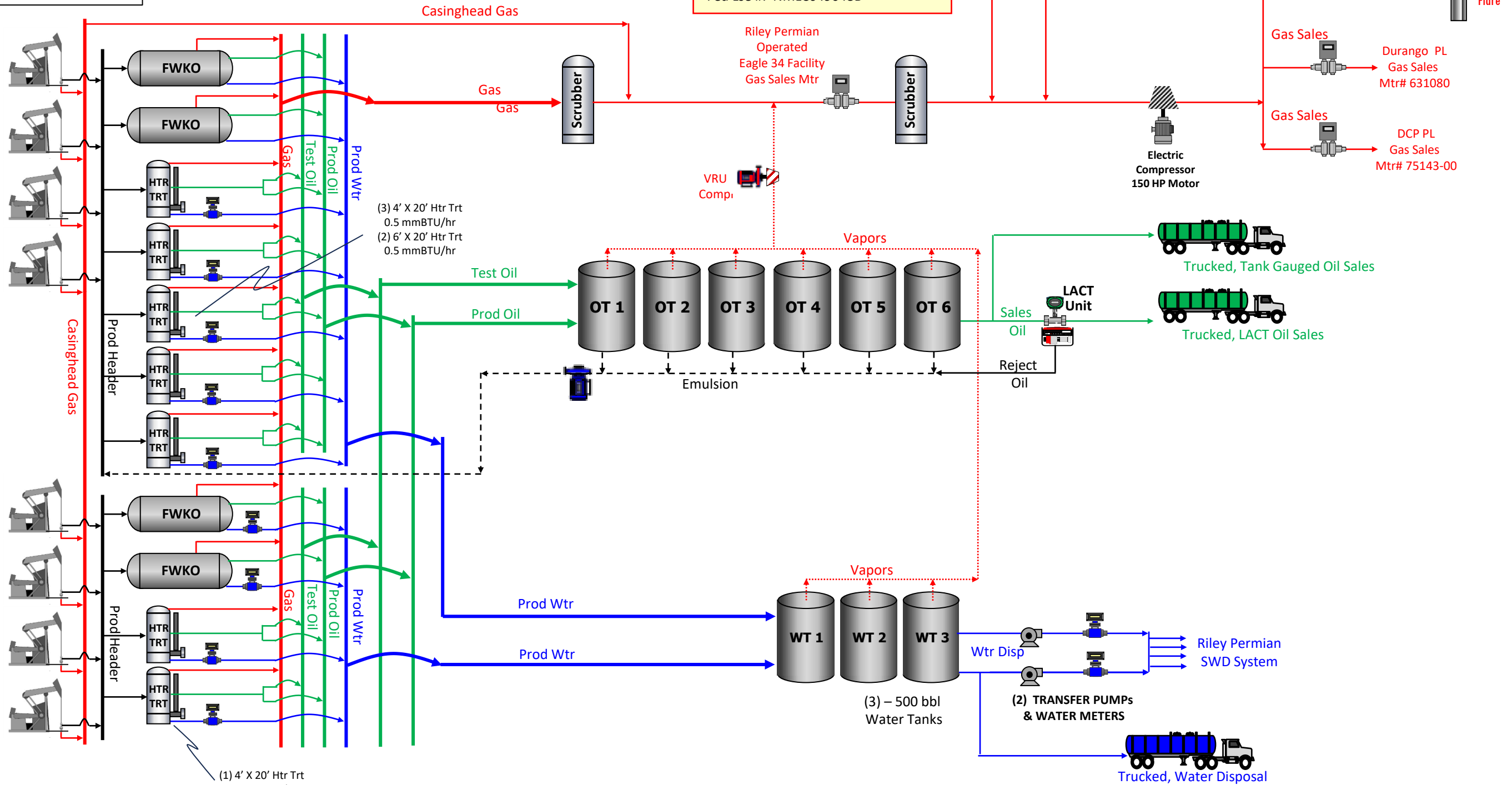

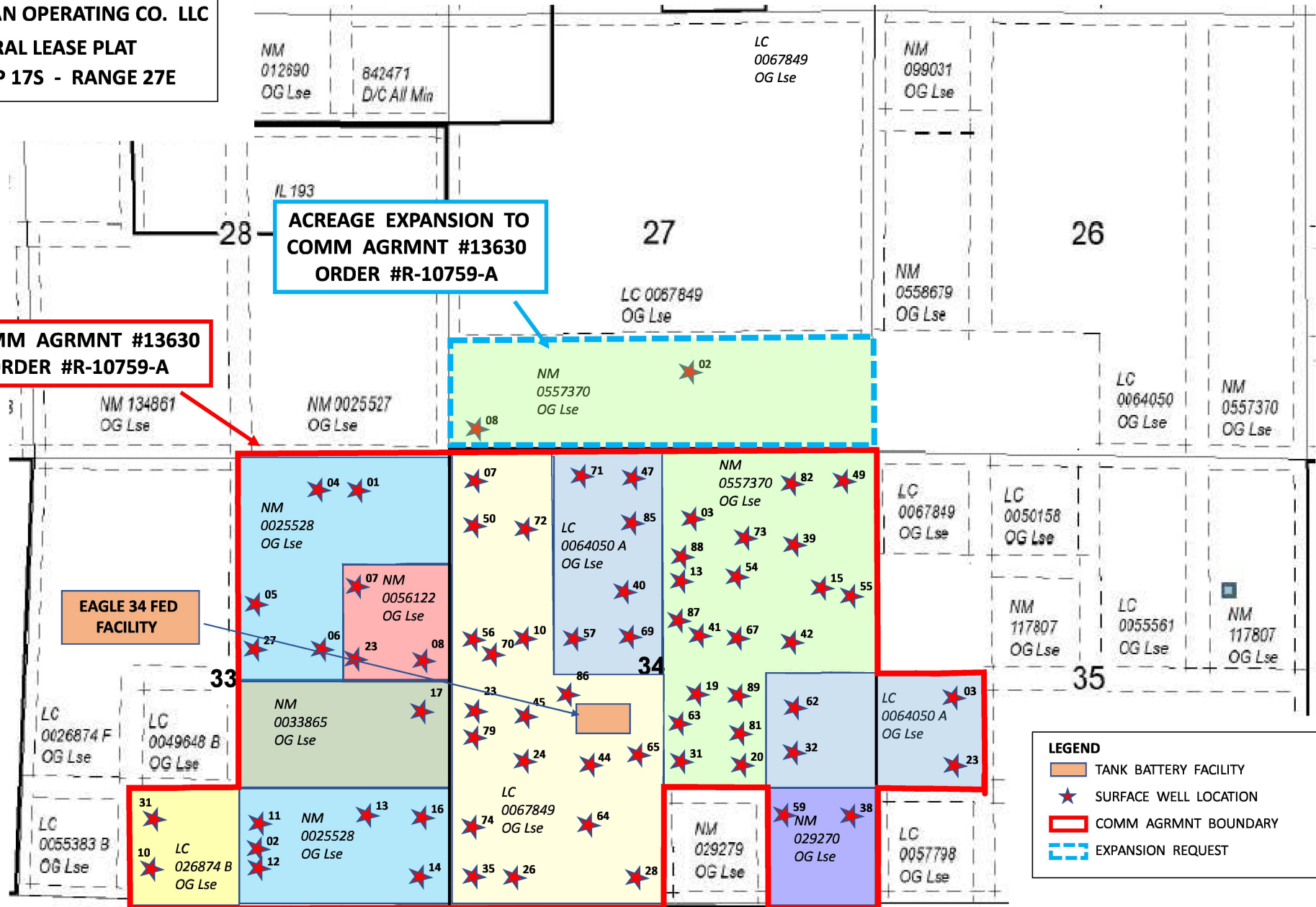

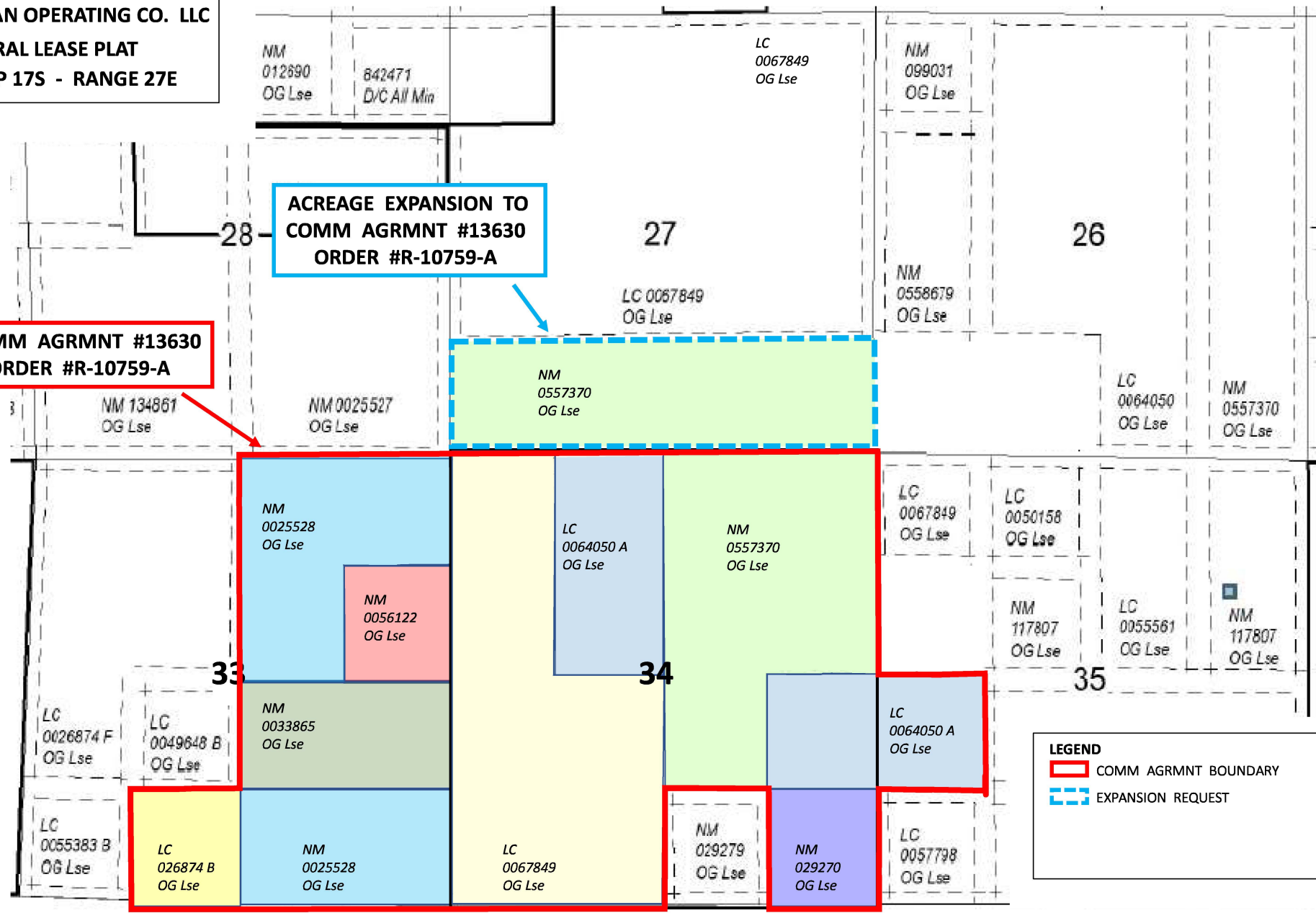

I have several years of experience in petroleum land matters, and I have worked directly or in a supervisory role with the properties that are the subject of these matters.
3. I am familiar with the Application filed by Riley in this case and the status of the lands in the subject lands.
4. Under Case No. 24502, Riley seeks to add additional leases and pools to the surface and pool commingling order approved by Order R-10759-A for the Eagle “34” Tank Battery located in the NE¼SW¼ (Unit K) of Section 34, Township 17 South, Range 27 East, N.M.P.M., Eddy County, New Mexico.

5. The Application includes a completed Form C-107-B Application for Surface Commingling (Diverse Ownership) to add two additional wells and an additional lease to the surface and pool commingling order approved by Order R-10759-A.

6. Applicant is the operator of the Northeast Red Lake Glorieta-Yeso Pool and the Red Lake Queen-Grayburg-San Andres Pool underlying United States Oil and Gas Leases NM 056122, LC 026874-B, NM 025528, NM 0557370, LC 064050-A, LC 067849, NM 033865, and NM 29270, which comprise all or parts of Sections 33, 34 and 35, Township 17 South, Range 27 East, N.M.P.M., Eddy County, New Mexico.
