In Case No. 24560, Permian Resources seeks an order pooling all uncommitted interests in the Third Bone Spring interval of the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of Sections 23 and 24, Township 20 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the **Bondi 24 Fed Com 131H** well, which will be drilled from a surface hole location in the NE/4 NE/4 (Unit A) of Section 24 to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 23. There is a

depth severance in the Bone Spring formation within the Unit. Therefore, Applicant seeks to pool interests from the top of the Third Bone Spring interval at a stratigraphic equivalent of approximately 7,624' MD to the base of the Bone Spring formation as shown on the Government AA #1 well log (API #30-015-21286).

The Unit will partially overlap with the spacing units for the Government AA Com #2 (API #30-015-33283) and Government AA Com #1 (API #30-015-21286) wells, which produce from the Burton Flat; Wolfcamp, North (Gas) pool (Code 73520).

In Case No. 24565, Permian Resources seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard, overlapping, horizontal

spacing unit comprised of the S/2 N/2 of Sections 23 and 24, Township 20 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the **Bondi 24 Fed Com 202H** well, which will be drilled from a surface hole location in the NE/4 NE/4 (Unit A) of Section 24 to a bottom hole location in the SW/4 NW/4 (Unit E) of Section 23. The Unit will partially overlap with the spacing units for the Government AA Com #2 (API #30-015-33283) and Government AA Com #1 (API #30-015-21286) wells, which produce from the Burton Flat; Wolfcamp, North (Gas) pool (Code 73520).

In Case No. 24566, Permian Resources seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard, overlapping, horizontal spacing unit comprised of the N/2 S/2 of Sections 23 and 24, Township 20 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the **Bondi 24 Fed Com 203H** well, which will be drilled from a surface hole location in the NE/4 SE/4 (Unit I) of Section 24 to a bottom hole location in the NW/4 SW/4 (Unit L) of Section 23. The Unit will partially overlap with the spacing unit for the Government Z Com #1 well (API #30-015-21242), which produces from the Burton Flat; Wolfcamp, North (Gas) pool (Code 73520).

In Case No. 24567, Permian Resources seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard, overlapping, horizontal spacing unit comprised of the S/2 S/2 of Sections 23 and 24, Township 20 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the **Bondi 24 Fed Com 204H** well, which will be drilled from a surface hole location in the NE/4 SE/4 (Unit I) of Section 24 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 23. The Unit will partially overlap with the spacing unit for the Government Z Com #1 well (API #30-015-21242), which produces from the Burton Flat; Wolfcamp, North (Gas) pool (Code 73520).

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Permian Resources Operating, LLC as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.
