NOTICE OF INTERVENTION

Civitas Permian Operating, LLC ("CIVI") submits to the Oil Conservation Division ("Division") this Notice of Intervention in the captioned cases pursuant to 19.15.4.11 NMAC. In support of this Notice, CIVI presents the following.

In these cases, Fasken Oil & Ranch, LTD ("Fasken") seeks extensions to Order Nos. R-22121 and R-22122 which designate Fasken as the operator of two (2) adjacent 320-acre horizontal well spacing units comprised of the W/2W/2 and the E/2W/2 of Sections 22 and 15, Township 20 South, Range 32 East, Lea County, New Mexico (the "Units").

CIVI has standing to intervene in the subject cases because it has a competing development plan. CIVI sent well proposals on June 5, 2024, for its Triple Stamp development which overlaps with Fasken's Units and intends to submit competing compulsory pooling applications. Additionally, based on the status conference held on May 2, 2024, and subsequent discussions with the parties, CIVI anticipates Marathon Oil Permian, LLC ("Marathon") will be submitting competing compulsory pooling applications that overlap with Fasken's Units.

CIVI also has standing to intervene in these cases because it is an operating rights owner entitled to notice of Fasken's proposed Federal Development Area ("DA") for the wells at issue in the captioned cases.

CIVI's intervention in these cases will allow it to participate in the adjudicatory process to ensure that all competing development plans will be considered in an efficient manner thus contributing substantially to the prevention of waste and the protection of correlative rights.

Accordingly, CIVI opposes extensions to Order Nos. R-22121 and R-22122 until all competing development plans have been considered by the Division.
