NOTICE OF INTERVENTION AND OBJECTION

Pursuant to Rule 19.15.4.11 NMRA, Murchison Oil and Gas, LLC (OGRID No. 15363) (“Murchison”) gives notice that it intervenes in these matters. In support of its intervention, Murchison states the following.

1. Murchison owns the working interest in the W/2 and S/2 NE/4 of Section 23, Township 24 South, Range 26 East, Eddy County, New Mexico, which is adjacent to the acreage Marathon Oil Permian, LLC (“Marathon”) seeks to pool in Section 22, Township 24 South, Range 26 East, Eddy County, New Mexico.

2. Murchison supports competing development plans that involve its acreage in Section 23 and the acreage Marathon seeks to pool in Section 22.

3. Murchison has standing to intervene in these matters because Marathon’s proposed development overlaps with, and would preclude, the planned development of Murchison’s acreage.

4. Murchison’s participation in the above referenced proceedings will contribute substantially to the prevention of waste and the protection of correlative rights.

5. For the foregoing reasons, Murchison has standing to intervene and objects to presentation of these cases by affidavit
