NOTICE OF INTERVENTION AND OBJECTION

Permian Resources Operating, LLC ("Permian") hereby appears in the above-referenced case and objects to the pooling application filed by Avant in this matter. Permian has standing to appear and intervene because it has a farmout agreement that covers the NW/4 SE/4 of Section 22, Township 19 South, Range 33 East, NMPM, Lea County, New Mexico, and has proposed wells in Section 22 to meet the obligations under the farmout agreement. Permian's development plan therefore overlaps Avant's proposed plans in Section 22. *See* Exhibit A, Permian Well Proposal. Permian did not receive notice of the hearing in this matter presumably because Permian does not hold a working interest in the acreage that Avant seeks to pool.

The Division has authority to allow late intervenors to participate when a final order has not been issued. 19.15.4.11.B NMAC; Commission Order R-21454. The Division has not yet entered a final pooling order in Case No. 24497. Therefore, the Division can, and should, allow Permian to intervene in this matter, allow Permian to file its competing pooling applications and set the matters for a contested hearing if the parties cannot reach agreement on a development plan for the subject acreage. *See* Commission Order No. R-21454.
