STATEMENT OF THE CASE

APPLICANT

Case No. 24618: Mewbourne Oil Company seeks an order pooling all mineral uncommitted interest owners in the Bone Spring formation underlying a horizontal spacing unit comprised of the W/2E/2 of Section 18 and the W/2E/2 of Section 7, Township 21 South, Range 35 East, NMPM. The unit will be dedicated to the North Wilson Deep Unit Well No. 8H, with a first take point in the SW/4SE/4 of Section 18 and a last take point in the NW/4NE/4 of Section 7.

Case No. 24619: Mewbourne Oil Company seeks an order pooling all uncommitted mineral interest owners in the Bone Spring formation underlying a horizontal spacing unit comprised of the E/2E/2 of Section 18 and the E/2E/2 of Section 7, Township 21 South, Range 35 East, NMPM. The unit will be dedicated to the North Wilson Deep Unit Well No. 9H, with a first take point in the SE/4SE/4 of Section 18 and a last take point in the NE/4NE/4 of Section 7.

Also to be considered will be the cost of drilling, completing, testing, and equipping the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling, completing, testing, and equipping the wells.


