STATEMENT OF THE CASES

In **Case No. 24449**, Earthstone seeks an order pooling uncommitted interests in the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the W/2 E/2 of Section 14 and the W/2 NE/4 of Section 23, Township 21 South, Range 34 East, Lea County, New Mexico. The Unit will be dedicated to the **Outland 14-23 State Com 123H** and **Outland 14-23 State Com 133H** wells, which will be drilled from surface hole locations in the NW/4 NE/4 (Unit B) of Section 14 to bottom hole locations in the SW/4 NE/4 (Unit G) of Section 23.

In **Case No. 24500**, Earthstone seeks an order pooling uncommitted interests in the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the E/2 E/2 of Section 14 and the E/2 NE/4 of Section 23, Township 21 South, Range 34 East, Lea County, New Mexico. The Unit will be dedicated to the dedicated to the **Outland 14-23 State Com 124H** and **Outland 14-23 State Com 134H** wells, which will be drilled from surface hole locations in the NW/4 NE/4 (Unit B) of Section 14 to bottom hole locations in the SE/4 NE/4 (Unit H) of Section 23.

The completed intervals of the wells will be orthodox. Also to be considered in each case will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Permian Resources Operating, LLC (OGRID No. 372165) as the operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The wells are located approximately 16 miles west of Eunice, New Mexico.
