APPLICANT'S STATEMENT OF THE CASE

In these consolidated cases, Applicant seeks orders pooling all uncommitted interests in Bone Spring and Wolfcamp formations underlying the W2 of Sections 20, 29 and 32, Township 24 South, Range 36 East, NMPM, Lea County, New Mexico, as follows:

• <u>Case 24613</u> seeks to pool as standard 960-acre horizontal well spacing unit in the Bone Spring formation under the W2 of Sections 20, 29 and 32 to be initially dedicated to the proposed **K. Stewart Fed Com 135H** well, to be horizontally drilled from a surface

location in the S2SW4 of Section 32, with a first take point in the SW4SW4 (Unit M) of Section 32 and a last take point in the NW4NW4 (Unit D) of Section 20. The completed interval of the K. Stewart Fed Com 135H is expected to remain within 330 feet of the adjoining quarter-quarter section (or equivalent) tracts to allow inclusion of these proximity tracts within the proposed horizontal spacing unit under 19.15.16.15.B(1)(b) NMAC.

- Case 24614 seeks to pool a standard 480-acre horizontal well spacing unit in the Wolfcamp formation under the W2W2 of Sections 20, 29 and 32 to be initially dedicated to the proposed **K. Stewart Fed Com 211H** well, to be horizontally drilled from a surface location in the S2SW4 of Section 32, with a first take point in the SW4SW4 (Unit M) of Section 32 and a last take point in the NW4NW4 (Unit D) of Section 20.
- <u>Case 24615</u> seeks to pool a standard 480-acre horizontal well spacing unit in the Wolfcamp formation under the E2W2 of Sections 20, 29 and 32 to be initially dedicated to the proposed **K. Stewart Fed Com 212H** well, to be horizontally drilled from a surface location in the S2SW4 of Section 32, with a first take point in the SE4SW4 (Unit N) of Section 32 and a last take point in the NE4NW4 (Unit C) of Section 20.

Applicant seeks to have Matador Production Company (OGRID No. 228937) designated as the operator of these proposed spacing units and been unable to obtain voluntary agreement for development of this acreage from all the affected mineral interest owners.
