**STATEMENT OF THE CASES**

In Case No. 24626 and Case No. 24627, Permian Resources requests that the Division pool additional uncommitted interests under the terms of Division Order Nos. R-23050 and R-23051.

On February 14, 2024, the Division entered Order Nos. R-23050 and R-23051, pooling uncommitted interests in the Bone Spring formation underlying a total of 640 acres in the S/2 of Sections 8 and 9, Township 19 South, Range 28 East, Eddy County, New Mexico, and dedicated the acreage to the Klondike 9 State Com #124H, Klondike 9 State Com #134H, Klondike 9 State Com #123H, and Klondike 9 State Com #133H wells.

Since the Orders were entered, Permian Resources has identified additional uncommitted interests in the Units that have not been pooled under the terms of the Orders. Permian Resources requests that these additional interests be pooled into the units pursuant to the terms of the Orders to allow Permian Resources to obtain its just and fair share of the oil and gas underlying the subject lands.
