#### **STATEMENT OF THE CASE**

In **Case No. 24628**, 3R requests a one-year extension of time to commence drilling operations and to pool additional interests under Order No. R-22844. The Division entered the Order in Case No. 23587 on August 25, 2023. The Order pooled uncommitted interests in the Bone Spring formation underlying a 640-acre, more or less, standard horizontal spacing unit comprised of the W/2 of Sections 7 and 18, Township 23 South, Range 26 East, Eddy County, New Mexico<sup>2</sup> and dedicated the Unit to the Rena 7 Fed Com 601H well.

In **Case No. 24629**, 3R requests a one-year extension of time to commence drilling operations and to pool additional interests under Order No. R-22845. The Order pooled uncommitted interests in the Bone Spring formation underlying a 640-acre, more or less, standard horizontal spacing unit comprised of the E/2 of Sections 7 and 18, Township 23 South, Range 26 East, Eddy County, New Mexico<sup>3</sup> and dedicated the Unit to the Rena 7 Fed Com 603H well.

In **Case No. 24630**, 3R requests one-year extension of time to commence drilling operations and to pool additional interests under Order No. R-22846. The Division entered the Order in Case No. 23589 on August 25, 2023. The Order pooled uncommitted interests in the Wolfcamp formation underlying a 640-acre, more or less, non-standard horizontal spacing unit

comprised of the W/2 of Sections 7 and 18, Township 23 South, Range 26 East, Eddy County, New Mexico<sup>4</sup> and dedicated the Unit to the Rena 7 Fed Com 702H well.

In **Case No. 24631**, 3R request a one-year extension of time to commence drilling operations and to pool additional interests under Order No. R-22847. The Order pooled uncommitted interests in the Wolfcamp formation underlying a 640-acre, more or less, standard horizontal spacing unit comprised of the E/2 of Sections 7 and 18, Township 23 South, Range 26 East, Eddy County, New Mexico<sup>5</sup> and dedicated the Unit to the Rena 7 Fed Com 704H well.

Good cause exists for 3R's requested extension of time to commence drilling the Rena 7 Fed Com 601H, 603H, 702H, and 704H wells because 3R's ability to commence drilling the wells has been impacted by delays in the issuance of federal drilling permits and limitations on gas takeaway.

Additionally, since the Orders were entered, 3R has identified additional uncommitted interests in the Units that have not been pooled under the terms of the Order. 3R withdraws its request to pool additional interests under the terms of Order Nos. R-22844 and R-22845, and only seeks to pool additional uncommitted interests under the terms of Order Nos. R-22846 and R-22847. 3R requests that these additional interests be pooled into the Unit pursuant to the terms of the Orders in order to allow 3R to obtain its just and fair share of the oil and gas underlying the subject lands.
