

**SELF-AFFIRMED STATEMENT OF JOSH ANDERSON**

Josh Anderson, being duly sworn upon his oath, deposes and states:

1. I am a landman for Mewbourne Oil Company (“Mewbourne”), and have personal knowledge of the matters stated herein. I have been qualified by the Division as an expert petroleum landman.

2. Pursuant to Division Rules, the following information is submitted in support of this compulsory pooling application.

3. The purpose of this application is to force pool Record Title owners into the Bone Spring horizontal spacing unit described below.

4. In this case Mewbourne seeks an order pooling all uncommitted mineral interest (Record Title) owners in the Bone Spring formation underlying a horizontal spacing unit comprised of the S/2S/2 of Section 12 and the S/2S/2 of Section 11, Township 18 South, Range 30 East, NMPM. The unit will be dedicated to the Sandbox 12/11 Fed. Com. Well No. 528H, a horizontal well with a first take point in the SE/4SE/4 of Section 12 and a last take point in the SW/4SW/4 of Section 11.

5. There is no depth severance in the Bone Spring formation.

6. A plat and C-102 outlining the unit being pooled are submitted as Exhibit 2-A.

7. Exhibit 2-B is a portion of a title opinion setting forth the Record Title ownership of federal leases in Sections 11 and 12, as well as their percentage interests. The persons being pooled are highlighted in yellow.

8. The interest owners being pooled have been contacted regarding the proposed well unit, but have failed or refused to voluntarily execute a communitization agreement.

9. In order to locate the interest owners, Mewbourne examined the county and federal records, performed internet searches, checked telephone records, and searched Accurint and Whitepages. Mewbourne has made a good faith effort to locate all Record Title owners in the well unit.

10. Exhibit 2-C contains a sample copy of the letters sent to the Record Title owners in the well unit. Mewbourne has made a good faith effort to obtain the voluntary joinder of the Record Title interest in the well unit.

11. Only Record Title owners of several federal leases are being pooled. This is necessary in order to obtain Bureau of Land Management approval of the communitization agreement for the well and well unit.

12. Because only Record Title owners, who own no working interest in the well, are being pooled, Mewbourne does not seek recovery of costs by this application. Therefore, an Authorization for Expenditure, overhead and administrative rates, and a risk charge are not provided or requested.

13. Mewbourne requests that it be designated operator of the well.

14. The attachments to this affidavit were prepared by me or compiled from company business records.

15. Granting this application is in the interests of conservation and the prevention of waste.

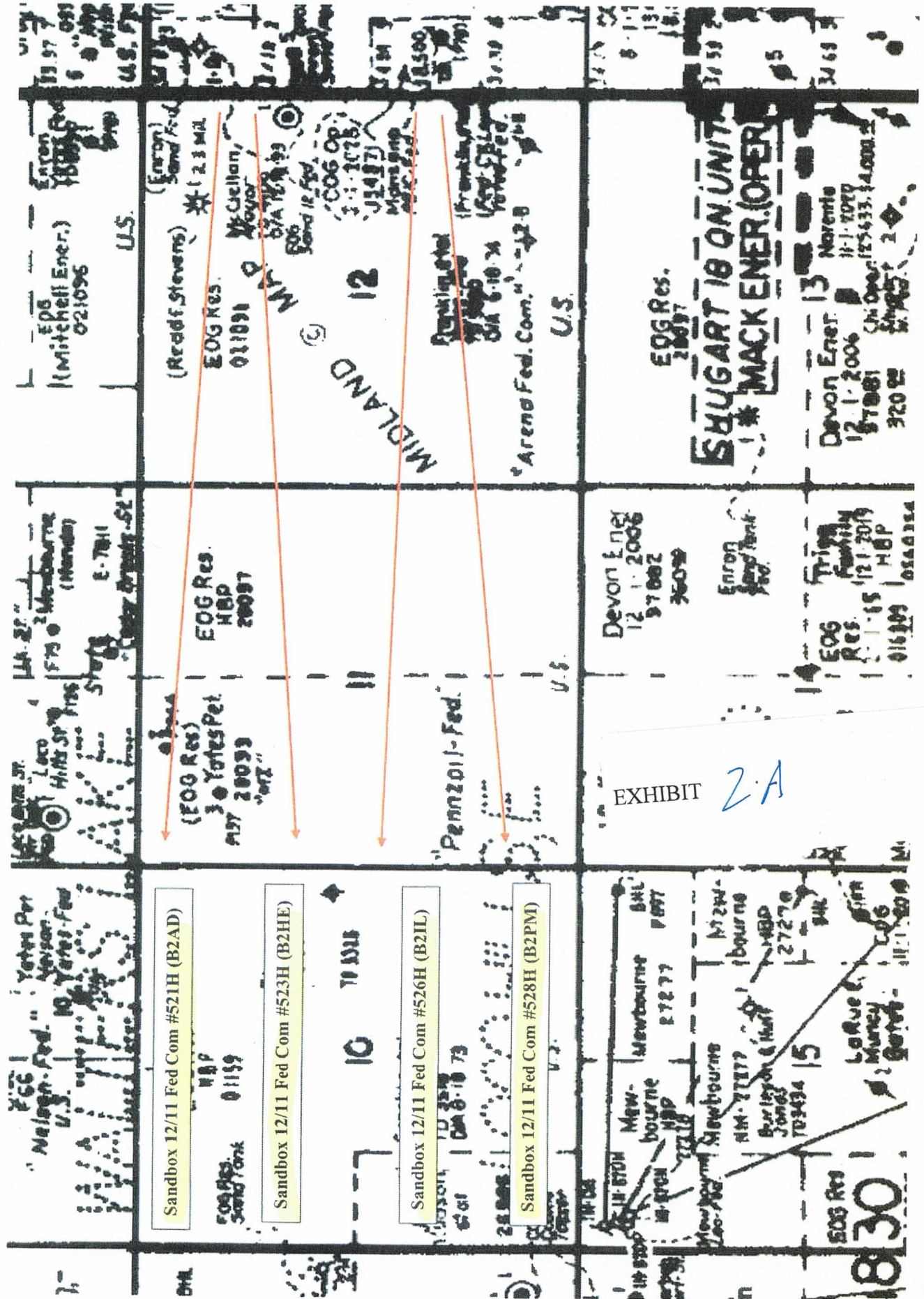



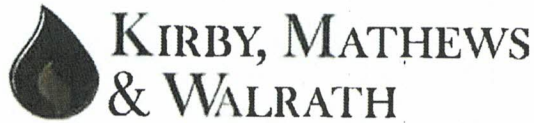
