STATEMENT OF THE CASES

In **Case No. 24670**, Mewbourne applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the W/2 W/2 of Section 16 and the W/2 NW/4 of Section 21, Township 19 South,

Range 33 East, Lea County, New Mexico. Mewbourne seeks to dedicate the Unit to the **Bushwood 21/16 Fed Com #521H** well, to be drilled from a surface hole location in the NW/4 SE/4 (Unit J) of Section 21 to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 16.

In **Case No. 24671**, Mewbourne applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Section 16 and the E/2 NW/4 of Section 21, Township 19 South, Range 33 East, Lea County, New Mexico. Mewbourne seeks to dedicate the Unit to the **Bushwood 21/16 Fed Com #523H** well, to be drilled from a surface hole location in the NW/4 SE/4 (Unit J) of Section 21 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 16.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The wells are located approximately 27 miles southwest of Lovington, New Mexico.
