**APPLICATION**

Permian Resources Operating, LLC (“Applicant” or “Permian”) (OGRID No. 372165), through its undersigned attorneys, hereby files this application with the Oil Conservation Division, to amend Order No. R-21104-E (the “Order”) to allow for a one-year extension for drilling the proposed initial well under the Order. In support of its application, Applicant states:

1. Division Order No. R-21104, entered on February 13, 2020 in Case No. 20860, and Order No. R-21104-A, entered on May 19, 2020 in Case No. 21257, created a 473.59-acre, more or less, standard horizontal spacing unit underlying the SW/4 of irregular Section 5, and Lots 6-7, the E/2 SW/4, and the SE/4 (S/2 equivalent) of irregular Section 6, Township 22 South, Range 27 East, NMPM, Eddy County, New Mexico (the “Unit”), and designated SPC Resources, LLC (“SPC”) as operator of the Unit.

2. Order Nos. R-21104 & 21104-A further pooled uncommitted interests in the Bone Spring formation (Esperanza; Bone Spring Pool (Pool Code 97755)) in the Unit and dedicated the Unit to the proposed initial **Barney #303H** well (formerly Barney 5-6 B3 3H well) (API No. 30-015-49106).

3. On April 12, 2021, the Division issued Order No. R-21104-B under Case No. 21574, pooling previously unidentified interest owners in the subject spacing unit.

4. In July 2021, the Division issued an emergency order suspending approval of SPC’s initial well in a nearby spacing unit over concerns involving the Carlsbad Brine Well Remediation

Area. The Division subsequently determined that drilling and completing wells near the Brine Well Remediation Area “poses a clear and immediate risk of harm to the stability of the [Carlsbad Brine Well] Cavity and the successful completion of the ongoing Carlsbad Brine Well remediation project[,]” and “to surface development and the groundwater aquifer overlying the Cavity.” *See* Order R-21888, ¶¶ 57-58; *see also* Division Application in Case No. 22472. As a result, the Division ordered the cessation of drilling and completion activities for wells within the vicinity of the Brine Well Remediation Area. *See generally* Order R-21888 and Case No. 22472.

5. On January 4, 2022, SPC applied in Case No. 22535 to Amend Order No. R-21104-B to extend the drilling deadlines until February 17, 2023 due to the Division’s suspension of drilling and completion activities.

6. After hearing, the Division issued Order No. R-21104-C on March 9, 2022, amending Order No. R-21104-B to extend the deadline to commence drilling until one year from the date SPC “receives notice that the Division has determined remediation of the Carlsbad Brine Well is complete and drilling and completion activities may resume.” *See* Order No. R-21104-C at ¶ 20.

7. SPC received notice from the Division that remediation of the Carlsbad Brine Well was complete and that drilling and completion activities could resume on July 7, 2022. *See* Notice of Resumption, dated July 7, 2022 in NMOCD Case No. 22535. Accordingly, Order No. R-21104-C changed the deadline to commence drilling an initial well under the Order to July 7, 2023.

8. On June 7, 2023, the Division issued Order No. R-21104-D under Case No. 23470, granting a one-year extension. On July 7, 2023, the Division also issued Order No. R-21104-E, correcting Paragraph 8 of Order No. R-21104-D to reflect the new deadline to commence drilling as July 7, 2024.

9. Permian has since acquired this property and seeks an additional one-year extension.

10. There is good cause for Applicant's request that the Order be amended to allow additional time to commence drilling the initial well under the Order.

11. Accordingly, Permian requests the deadline to commence drilling an initial well under Order No. R-21104, as amended, be extended for one year until July 7, 2025.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on July 11, 2024, and, after notice and hearing as required by law, the Division amend Order No. R-21104, as amended, to extend the time to commence drilling the proposed initial well until July 7, 2025.

**SELF-AFFIRMED STATEMENT OF CHRIS ASTWOOD**

1. My name is Chris Astwood. I work for Permian Resources Operating, LLC (“Permian”) as a Senior Landman. SPC Resources, LLC (“SPC Resources”) is a wholly owned subsidiary of Permian. Permian closed on the acquisition of SPC Resources in December 2023 with an effective date in September 2023.

2. I have previously testified before the New Mexico Oil Conservation Division as an expert witness. My credentials in petroleum land matters have been accepted by the Division and made a matter of record.

3. I am familiar with the application filed by Permian Resources in this case, and I am familiar with the status of the lands in the subject area.

4. None of the parties in this case have indicated opposition, therefore I do not expect any opposition at the hearing.

5. In this case, Permian Resources seeks an order to amend Order No. R-21104-E (the “Order”) to allow for a one-year extension for drilling the proposed initial well under the Order.

6. The Order originally designated SPC Resources, LLC as operator. SPC is now a wholly owned subsidiary of Permian Resources under a transaction that closed in December 2023 with an effective date in September 2023. An amended order should, therefore, reflect that Permian Resources is the operator of record.

7. **Permian Resources Exhibit A** is a copy of the Application that was filed in this case. It accurately recites the history and background of the original order pooling the subject acreage and subsequent amendments.

8. Good cause exists for Applicant's request that the Order be amended to allow additional time to commence drilling the initial well under the Order.

9. As noted, Permian Resources recently acquired SPC Resources and has undertaken a careful re-assessment of SPC's existing pooling orders and drilling plans in the Carlsbad area. As a result of this review, Permian Resources has recently filed for and received amended pooling orders in several cases within the Carlsbad area adding additional wells and reconfiguring the proposed spacing units and seeking deadline extensions in order to complete the work. Permian Resources is now in the process of drilling the approved initial wells under those recently amended orders.

10. For example, Permian Resources is currently drilling a five-well Wolfcamp package on its existing Betty and Barney spacing units under Order Nos. R-21100, as amended, and R-21123, as amended, respectively. Following the drilling and completion of those wells, Permian Resource's rig is scheduled this fall to drill a nine-well package in its Caveman Wolfcamp and Hannah Bone Spring spacing units under Order Nos. R-21096, as amended, and R-23221, as amended, respectively. Additional Carlsbad area wells are expected to be added to Permian Resources' drilling schedule over the next few months. With this heavy drill schedule and prior drilling commitments necessary to meet other pre-existing order deadlines, Permian Resources requires additional time to drill and complete the Barney 303H well under Order No. R-21104-E.



11. In addition, Permian Resources is in good standing with the Division's compliance requirements and regulations.

12. Permian Resources and its predecessor-in-interest, SPC Resources, have also invested significant effort and time at substantial cost to identify and locate mineral owners within the subject acreage, reach voluntary agreement with many owners, and force pool interests that remain uncommitted.

13. Finally, none of the working interest owners that remain subject to this pooling order have been asked to make an election on the applicable wells, or to pay their estimated share of the costs to drill, complete, and equip the applicable wells. And no other operator has proposed to drill or develop the subject acreage.

14. Approval will allow Applicant to obtain a just and fair share of the oil and gas underlying the subject lands, avoid the drilling of unnecessary wells, will prevent waste, and will protect correlative rights.

15. In my opinion, an extension is justified under these circumstances.

16. Granting these applications will further the interests of preventing waste and protecting correlative rights.

17. I provided a list of the parties subject to pooling in this case to the law firm of Holland & Hart LLP for purposes of providing notice of this application and hearing.

18. I affirm under penalty of perjury under the laws of the State of New Mexico that the foregoing statements are true and correct. I understand that this self-affirmed statement will be used as written testimony in this case. This statement is made on the date next to my signature below.
