### STATEMENT OF THE CASES

In Case No. 24689, Applicant seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of Section 11 and the N/2 NW/4 of Section 12, Township 20 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the Kangaroo 12 Fed Com 201H well, which will be drilled from a surface hole location in the SE/4 NW/4 (Unit F) of Section 12 to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 11.

In Case No. 24690, Applicant seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the S/2 N/2 of Section 11 and the S/2 NW/4 of Section 12, Township 20 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the **Kangaroo 12 Fed Com 202H** well, which will be drilled from a surface hole location in the SE/4 NW/4 (Unit F) of Section 12 to a bottom hole location in the SW/4 NW/4 (Unit E) of Section 11.

In Case No. 24691, Permian Resources seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the N/2 S/2 of Section 11 and the N/2 SW/4 of Section 12, Township 20 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the **Kangaroo 12 Fed** Com 203H well, which will be drilled from a surface hole location in the NE/4 SW/4 (Unit K) of Section 12 to a bottom hole location in the NW/4 SW/4 (Unit L) of Section 11.

In Case No. 24692, Permian Resources seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the S/2 S/2 of Section 11 and the S/2 SW/4 of Section 12, Township 20 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the **Kangaroo 12 Fed Com** 204H well, which will be drilled from a surface hole location in the NE/4 SW/4 (Unit K) of Section 12 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 11.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The wells are located approximately 16 miles northeast of Carlsbad, New Mexico.
