STATEMENT OF THE CASES

In **Case No. 24394**, Applicant seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 160.2 acre, more or less, standard horizontal spacing unit

comprised of the W/2 W/2 of Section 4, Township 23 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the **Goonch Federal Com 111H** and **Goonch Federal Com 121H** wells, which will be drilled from surface hole locations in the SW/4 SW/4 (Unit M) of Section 4 to bottom hole locations in the NW/4 NW/4 (Unit D) of Section 4

In **Case No. 24395**, Applicant seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 160.21 acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Section 4, Township 23 South, Range 28 East, Eddy County, New Mexico. The Unit will be dedicated to the **Goonch Federal Com 112H** and **Goonch Federal Com 122H** wells, which will be drilled from surface hole locations in the SW/4 SW/4 (Unit M) of Section 4 to bottom hole locations in the NE/4 NW/4 (Unit C) of Section 4.

The completed intervals of the wells will be orthodox. Also to be considered in each case will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as the operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The wells are located approximately 16 miles west of Eunice, New Mexico.
