STATEMENT OF THE CASES

In Case Nos. 24638, 24639, 24640, and 24641, E.G.L. requests an extension of time to commence drilling operations under Order Nos. R-22821, R-22822, R-22823, and R-22824, respectively, due to delays in the issuance of federal drilling permits.

In Case No. 24638, E.G.L. seeks a one-year extension of time to commence drilling operations under Order No. R-22821, which was entered by the Division on August 4, 2023. Order No. R-22821 pooled all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 W/2 of Sections 13 and 24, Township 19 South, Range 33 East, Lea County, New Mexico, and dedicated the unit to the Millie Mile 13-24 Fed. Com. Well No. 101H and Millie Mile 13-24 Fed. Com. Well No. 201H.

In Case No. 24639, E.G.L. seeks a one-year extension of time to commence drilling operations under Order No. R-22822, which was entered by the Division on August 4, 2023. Order No. R-22822 pooled all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Sections 13 and 24, Township 19 South, Range 33 East, Lea County, New Mexico, and dedicated the unit to the Millie Mile 13-24 Fed. Com. Well No. 102H and Millie Mile 13-24 Fed. Com. Well No. 202H.

In Case No. 24640, E.G.L. seeks a one-year extension of time to commence drilling operations under Order No. R-22823, which was entered by the Division on August 4, 2023. Order No. R-22823 pooled all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 W/2 of Sections 13 and 24, Township 19 South, Range 33 East, Lea County, New Mexico, and dedicated the unit to the Millie Mile 13-24 Fed. Com. Well No. 401H.

In Case No. 24641, E.G.L. seeks a one-year extension of time to commence drilling operations under Order No. R-22824, which was entered by the Division on August 4, 2023. Order No. R-22824 pooled all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Sections 13 and 24,

Township 19 South, Range 33 East, Lea County, New Mexico, and dedicated the unit to the Millie Mile 13-24 Fed. Com. Well No. 402H.
