**STATEMENT OF THE CASES**

In **Case No. 24707**, E.G.L. seeks an order pooling additional uncommitted interests under the terms of Order No. R-22821. The Division entered the order in Case No. 23329 on August 4,

2023. The order: pooled all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 W/2 of Sections 13 and 24, Township 19 South, Range 33 East, Lea County, New Mexico; dedicated the Unit to the Millie Mile 13-24 Federal Com No. 101H and Millie Mile 13-24 Federal Com 201H wells; and designated Applicant as operator of the Unit and Wells. Since the Order was entered, Applicant has identified additional uncommitted interests in the unit that should be pooled under the terms of the order.

In **Case No. 24708**, E.G.L. seeks an order pooling additional uncommitted interests under the terms of Order No. R-22822. The order: pooled all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Sections 13 and 24, Township 19 South, Range 33 East, Lea County, New Mexico; dedicated the Unit to the Millie Mile 13-24 Federal Com No. 102H and Millie Mile 13-24 Federal Com 202H wells; and designated Applicant as operator of the unit and wells. Since the order was entered, Applicant has identified additional uncommitted interests in the unit that should be pooled under the terms of the order.

The Wells are located approximately 7 miles east-northeast of Halfway, New Mexico.
